

# NOTICE OF TENTATIVE DETERMINATION INTENT TO DENY AN UNDERGROUND INJECTION CONTROL PERMIT FOR THE FOLLOWING DISCHARGES INTO THE WATERS OF THE STATE OF CONNECTICUT

## **1.0 TENTATIVE DETERMINATION**

In accordance with applicable federal and state law and sections 22a-430-4(e)(2),(5), (g)(1), and (p)(2), (3) of the Regulations of Connecticut State Agencies ("RCSA"), the Commissioner of the Department of Energy and Environmental Protection ("DEEP") hereby gives notice of a tentative determination to deny a permit based on an application submitted by Alison Pastorfield Associates, Inc. ("the applicant") under section 22a-430 of the Connecticut General Statutes ("CGS") for a permit to discharge into the waters of the state.

### 2.0 APPLICANT'S PROPOSAL

Alison Pastorfield Associates, Inc. proposed a treatment and disposal system for the discharge of a maximum of 34,500 gallons per day of treated domestic sewage to groundwater from a 115, 2-bedroom unit age restricted residential development. On November 21, 2013, DEEP's Office of Adjudications provided a favorable Final Decision for permit issuance contingent on the submittal and approval of construction plans and specifications. On June 22, 2023, DEEP notified the applicant of the outstanding submissions and provided notification of potential permit denial if approvable documents were not submitted. The applicant has not submitted documents for approval, but submitted information documenting Alison Pastorfield Associates, Inc.'s dissolution.

#### **3.0 COMMISSIONER'S AUTHORITY**

The Commissioner is authorized to approve or deny such permits pursuant to section 22a-430 of the Connecticut General Statutes (CGS), sections 22a-430-3 and 4 of the RCSA, and section 1421 of the Federal Safe Drinking Water Act 42 USC et. seq.

## 5.0 PUBLIC COMMENT

Prior to making a final determination to approve or deny any application, the Commissioner shall consider written comments on the application from interested persons that are received within thirty (30) days of this public notice. Written comments should be emailed to Antoanela Daha at <u>Antoanela.daha@ct.gov</u>. The Commissioner may hold a public hearing prior to approving or denying an application if in the Commissioner's discretion the public interest will be best served thereby and shall hold a hearing upon receipt of a petition signed by at least twenty-five persons. Notice of any public hearing shall be published at least thirty (30) days prior to the hearing.

# **6.0 PETITIONS FOR HEARING**

Petitions for a hearing shall be submitted within thirty (30) days from the date of publication of this public notice and should include the application number noted above and also identify a contact person to receive notifications. Petitions may also identify a person who is authorized to engage in discussions regarding the application and, if resolution is reached, withdraw the petition. DEEP's Office of Adjudications will accept electronically-filed petitions for hearing in addition to those submitted by mail or hand-delivered. Petitions with required signatures may be sent to <u>deep.adjudications@ct.gov</u>; those mailed or delivered should go to the DEEP Office of Adjudications, 79 Elm Street, Hartford, CT 06106. If the signed original petition is only in an electronic format, the petitions that were filed electronically must also be mailed or delivered to the DEEP Office of Adjudications within thirty (30) days of electronic submittal.
