Guidelines for UIC Class VI Applicants: Submitting Electronic Proprietary Business Information Last Update: 02/2024 For EPA Class VI UIC Permit Applicants

This document is intended for applicants submitting Underground Injection Control (UIC) Class VI permit applications to the Environmental Protection Agency with a confidentiality claim. A confidentiality claim could include information that contains a trade secret, proprietary, or confidential business information (collectively called PBI).

As of August 2023, EPA's <u>Geologic Sequestration Data Tool (GSDT)</u> was updated to allow submittal of PBI. All documentation, including documentation with claimed PBI, should be submitted via the GSDT. See the GSDT Operator Landing Page for more information on PBI, including applicable regulations such as 40 CFR 2.203. Please note you must have an account to access the GSDT Operator Landing Page. See **Attachment 1** for directions on how to submit PBI via the GSDT.

When submitting documents with PBI through the GSDT, applicants should upload two versions of each document – one redacted version and one complete version with PBI markings ("marked-up version"). The marked-up version should clearly identify the specific information claimed as PBI, using methods such as in-line text, a highlighter tool or putting a red box around the text, images, table, etc. Whichever method selected, please be consistent with the method throughout. The marked-up version should directly correspond to the redacted version; anything that is redacted for confidentiality purposes in the redacted version must be identified in the marked-up version. See **Attachment 2** for examples of marked-up and redacted documents. Applicants should never submit a document that contains PBI that is not either redacted or clearly marked to indicate the exact location of your information claimed as PBI. *Failure to assert your PBI claim may result in the Agency making the information available to the public without further notice to the submitting Applicant.*

EPA also requests the following of applicants:

- Submit a crosswalk that summarizes the documents within the application, and which documents contain claimed PBI. An example crosswalk is provided as **Attachment 3**.
- All documents with claimed PBI should indicate this at the beginning of the file name by including "PBI" at the beginning of the file name. For example, instead of "Narrative Document_V1" the document with claimed PBI should read "PBI_ Narrative Document_V1". Redacted documents should not have words like "Confidential" in the file name, but may have the word "Redacted" for clarity e.g. "Narrative Document_V1_Redacted".

All documents submitted that contain PBI should have a "PBI" prefix in their filenames. Please stamp, or type, "claimed as proprietary business information," or "claimed as PBI." That as earer" on all PBI documents submitted. Allegedly confidential portions of otherwise non-confidential documents should be clearly identified. Please also indicate a date or event, if any, after which the information no longer need be treated as confidential. EPA requests that redacted copies of such documents also be provided.								
If a PBI claim does not accompany the information at the time it is submitted to EPA, then the Agency may make the information available to the public without further notice. See 40 CFR 2.203(c); 41 Fed. Reg. 36,902 (September 1, 1976).

IMPORTANT: If you are uploading a file that includes PBI within, you must make appropriate redactions within the document **before** uploading the document to the module. Clicking that something is PBI in the GSDT will only indicate that the file has been claimed as PBI.

Preferred method to redact text:

Load the document into Adobe Acrobat Pro. Click on "All tools" and select "**Redact a PDF**." Before making any redactions to your PDF, click on "Set properties", check the box for "Use Overlay Text", and enter "Claimed as PBI" into the custom text field. Click OK.

Next, use the **Redact** tool in Acrobat Pro to select all PBI text and images for redaction. *As you are selecting information to be redacted, remember that confidentiality claims may require substantiation and the applicant will bear the burden of that substantiation.* Before applying the redactions, but with the redactions all highlighted, save a copy of the document with PBI that is unredacted. To indicate that the document contains accessible PBI, indicate this in the filename: "PBI_FileNameHere.pdf."



Once the PBI document has been saved, (1) apply the redactions, and (2) in the next pop-up window, click "continue" to sanitize and remove hidden information. NOTE: please be sure to sanitize your document after applying your redactions. Failure to sanitize your document may result in your redactions not saving properly and your information being inadvertently disclosed. The redacted version of the document should not have "PBI" in the files name and should instead have the word "Redacted" to indicate that this is a document that does not require confidential handling.

IMPORTANT: Text that is merely highlighted black in Word is not a protected redaction and will remain accessible text. Text intended as PBI must be redacted in an appropriate program with a Redact tool or equivalent, such as Adobe Acrobat Pro.

So that the permitting authority can see/review PBI, please submit both the redacted and marked-up versions of the documents. To do this, zip the version with PBI marked but unredacted and the version with redactions. Include this new zip file as the document to be uploaded to the GSDT module.

Please use this submission to indicate the information claimed as PBI, the length of time this information will be considered PBI, etc. A template for the form is available for download on the Complete Submission tab.
