The discharge from this facility is located at 5150 E. Lohman Avenue, City of Las Cruces, Dona Ana County, New Mexico. Under the SIC code 4952, the applicant (municipality) operates East Mesa Water Reclamation Facility, which has a design flow rate of 1.0 MGD serving a population of 4,250 approximately. Effluent is discharged via Outfall 001 to South Fork Las Cruces Arroyo, an intermittent stream, thence to Rio Grande River (20.6.4.98 NMAC). Designated uses of the receiving water are stated in the fact sheet.

This is a renewal of a permit issued on February 27, 2019, with an effective date of April 1, 2019, and an expiration date of March 31, 2024.

Changes from the previous permit are:

- New limitations for PCBs have been added.
- Previous monitoring for thallium has been removed.
- Previous limitations for Bis(2-ethylhexyl) phthalate have been removed, but monitoring is required.
- Optional MPN unit for E. coli bacteria has been added.
- WET has new limit for Pimephales promelas.
- PFAS monitoring has been established.
