REQUEST FOR AIS WAIVER on the Waterline Replacement and Well Connection project for Pomerene Domestic Water Improvement District located at Pomerene, Arizona. WIFA Project No. DW 042-2023.

The statute permits EPA to issue waivers for a case or category of cases where EPA finds (1) that applying these requirements would be inconsistent with the public interest; (2) *iron and steel products are not produced in the US in sufficient and reasonably available quantities and of a satisfactory quality*; or (3) inclusion of iron and steel products produced in the US will increase the cost of the overall project by more than 25 percent.

MATERIALS

The materials are as follows: two ISO standard new (one trip) 40-ft steel cargo containers (40' long x 8' wide x 9.5' high) with double steel cargo doors with lock box and marine-grade plywood floors. The containers will be used for bulk storage. Information from the manufacturer about the materials comprising these expansion joints is attached.

ISSUE

The specified shipping containers are not manufactured in the United States. Different supplies were contacted and each stated that their product was manufactured or sourced outside of the United States. Communications between the contractor, supplier and manufacturer are included regarding the effort to obtain AIS-certified materials.

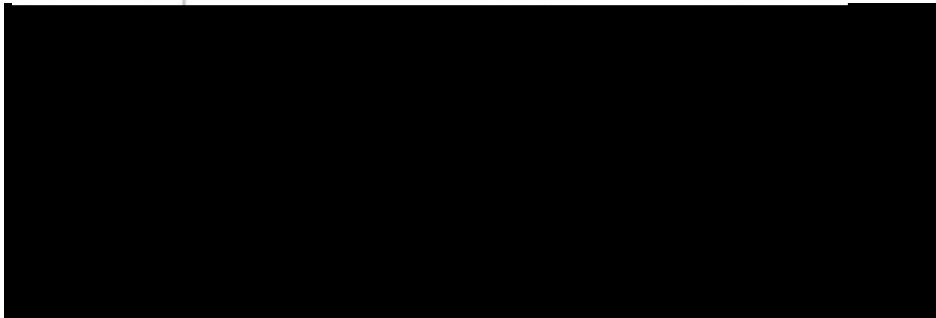
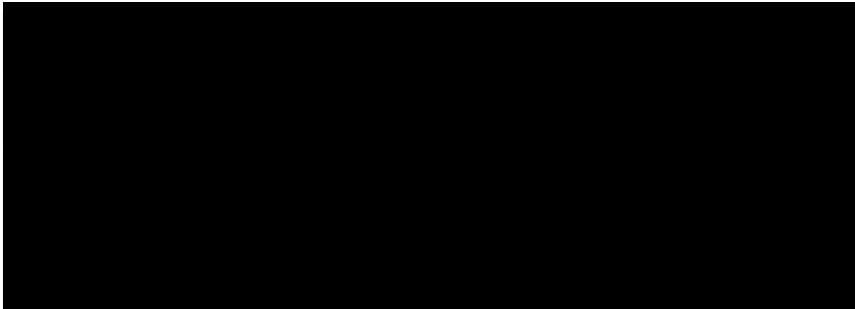
PROPOSED RESOLUTION

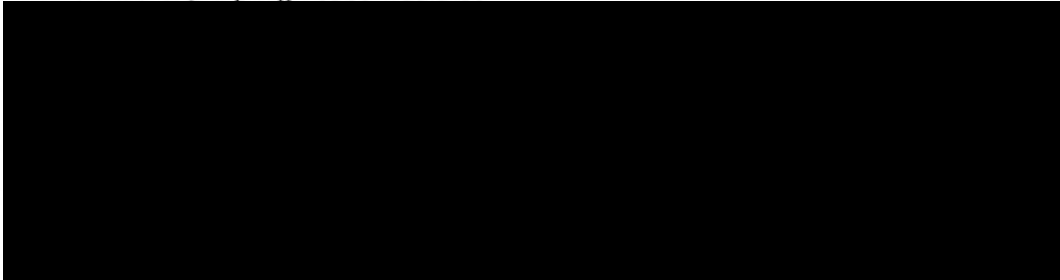
