Re: Tesoro Corporation's Petition for Waiver of 2014 Applicable Volumes of the Renewable Fuel Standard

Dear Administrator McCarthy:

Pursuant to § 211(o)(7)(A) of the Clean Air Act, 42 U.S.C. § 7545(o)(7)(A), and for the reasons set forth in the August 13, 2013 Petition for Partial Renewable Fuel Standard (RFS) Mandate Wavier submitted to your office by the American Fuel & Petrochemical Manufacturers (AFPM) and the American Petroleum Institute (API), Tesoro Corporation (Tesoro) submits this petition for a waiver of the 2014 applicable volumes of the Renewable Fuel Standard (RFS). As noted in the August 13, 2013 Petition, EPA must take action to avoid the adverse consequences that the RFS blendwall will have on the national fuel market.

Tesoro is a regulated party and is subject to the requirements of the RFS program. As such, Tesoro hereby incorporates into this petition, in its entirety, the AFPM and API's Petition for Partial RFS Mandate Wavier, dated August 13, 2013. As demonstrated by the August 13, 2013 Petition, the current 2014 applicable volumes of the RFS will severely harm the economy or environment of the United States and will result in an inadequate domestic supply of gasoline and diesel fuel.

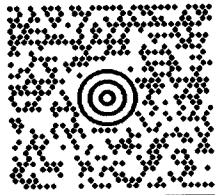

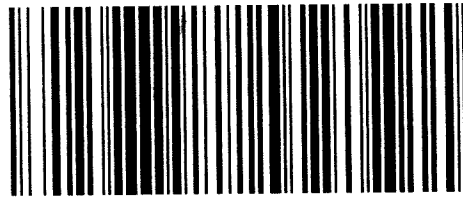
