In accordance with Section 309(g) of the Clean Water Act (CWA), 33 U.S.C. § 1319(g) and 40 CFR § 22.45, notice is hereby given that the U.S. Environmental Protection Agency Region 3 (EPA Mid-Atlantic Region), is proposing to file an Expedited Settlement Agreement (ESA) assessing an administrative civil penalty in the amount of ten thousand dollars (\$10,000) against the Respondent named below for alleged violations of Section 301 of the CWA and 40 C.F.R. § 122.26 for failure to have a National Pollutant Discharge Elimination System (NPDES) permit or permit coverage for the discharge of stormwater related to industrial activities.

Oden II, LLC d/b/a Lebarron's Auto Salvage 305 Zeigler Road Dover, PA 17315

**SUMMARY OF VIOLATIONS**: EPA Mid-Atlantic Region alleges the following violation of Section 301(a) of the CWA and 40 C.F.R. § 122.6, which was discovered during a February 7, 2023, inspection by the EPA at Oden II, LLC d/b/a Lebarron's Auto Salvage located at 305 Zeigler Road, PA 17315:

1. Failure to have a permit or permit coverage. On February 7, 2023, Respondent was in violation of the CWA as it was not authorized to discharge storm water associated with industrial activities from Oden II, LLC d/b/a Lebarron's Auto Salvage located at 305 Zeigler Road, Pennsylvania by any NPDES permit issued pursuant to the CWA. The EPA observed on February 7, 2023, evidence of discharges of storm water into an unnamed tributary to Conewago Creek, a water of the United States within the meaning of Section 502(7) of the CWA, 33 U.S.C. § 1362(7).

Discharges of industrial storm water from Oden II, LLC d/b/a Lebarron's Auto Salvage without authorization from any permit issued pursuant to the CWA constitute a violation of 40 C.F.R. § 122.26 and Section 301(a) of the CWA.

**OPPORTUNITY FOR COMMENT**: Persons wishing to comment on the (ACTION) are invited to submit via email a statement to the EPA Mid-Atlantic Region Enforcement and Compliance Assurance Division Director.
