More on CommuniTree:

Founded in 2016, CommuniTree is Northwest Indiana's (NWI) flagship urban and community forestry program that brings together nonprofits, communities, government agencies, universities, and industries. As of 2023, CommuniTree has planted over 10,000 trees on public, private, and industrial lands; engaged over 2,500 volunteers; trained more than 40 youth with urban forestry job skills; partnered with more than 40 communities; and held more than 20 urban forestry trainings. Core partners include the Northwestern Indiana Regional Planning Commission (NIRPC), the Student Conservation Association (SCA), the Wildlife Habitat Council (WHC), the US Forest Service (USFS), the NWI Urban Waters Federal Partnership, and others. The success of CommuniTree has been made possible through strong funding support from federal, state, local and private entities with similarly strong matching investments from municipalities, organizations, and volunteers across the region.

Indiana Arborist Association Receives \$250,000 Grant for a Registered Arborist Apprenticeship Program in NWI



The Indiana Arborist Association (IAA) has received \$250,000 in funding from Indiana Department of Natural Resource's Community and Urban Forestry program to launch the first ever workforce development program dedicated to training certified arborists from under-resourced communities in Northwest Indiana (NWI). This grant is funded through the U.S. Department of Agriculture (USDA) Forest Service Urban & Community Forestry program.

The IAA strives to enhance the quality of life for Indiana residents by encouraging the planting, maintenance and preservation of trees and promoting the advantages of working with qualified professional arborists who use current industry standards. Ashley Mulis, who will serve as program manager for the initiative is excited for this opportunity. "The need for qualified arborists in NWI has consistently surpassed the number of available practitioners. The IAA is thrilled to be able to launch such an important program in an area of the state that has historically suffered from both lack of tree canopy and certified arborists."

The Arborist Apprenticeship program will be a collaborative effort with several partners in NWI including Purdue University Northwest (PNW), Purdue Extension, the Center for Workforce Innovation, the US Forest Service, the NWI UWFP, among others. PNW Chancellor Kenneth Holford had this to say of the program partnership with IAA: "Purdue University Northwest is pleased to be a partner in this innovative workforce development program aimed at filling a growing and increasingly important gap in local talent to enhance the urban forests and ecosystems throughout Northwest Indiana. This program is consistent with PNW's goal of building a strong, skilled, and sustained workforce for the region."

"The Center of Workforce Innovations applauds IAA on their work to bring this transformational program to NWI. Disadvantaged communities often bear the brunt of climate change impacts and environmental degradation. Training individuals from these communities in climate adaptation and mitigation strategies can lead to healthier local environments. The CommuniTree program, in conjunction with this Arborist Apprenticeship program specifically aims to not only reverse these environmental impacts but also equip residents of those same communities with the skills and knowledge necessary to thrive in the emerging green economy through a proven work-and-learn model." Shaun Sahlhoff, Director of Planning and Fundraising at the Center of Workforce Innovations.

According to Victoria Wittig, the Northwest Indiana Urban Waters Federal Partnership Ambassador, "CommuniTree, an outgrowth of the NWI UWFP, has created an unparalleled opportunity for this workforce development initiative. Arborists trained through the apprenticeship program will support the continued growth, diversity and health of our urban forests by drawing on the strengths that regional partnerships bring to the table."

National Sea Grant Law Center Coastal Resilience Program Competition

The National Sea Grant Law Center is accepting applications from institutions of higher education, government agencies, and non-profit organizations to conduct research on the effectiveness of laws and policies related to a wide range of coastal resilience issues including sea level rise, flooding, amplified storm surge, increased frequency and intensity of storms, land use, or other environmental factors, and whether those policies are achieving desired policy changes. The 2024 Coastal Resilience Program grants have a recommended funding level of \$75,000, and the Law Center anticipates selecting up to two projects for funding. Matching funds will not be required. Legacy Foundation Transform Lake County Grant

NIPSCO Environmental Action Grant

Each spring, NIPSCO supports environmental restoration and education projects and programs throughout northern Indiana with funding from the Environmental Action Grant. Grants are available in the amount of \$500 to \$5,000. Eligible organizations must be a 501(c)3 or other non-profit as determined by the Internal Revenue Service with an environmental restoration or education project or program and have a direct impact in the NIPSCO service area. National Fish and Wildlife Foundation (NFWF) National Coastal Resilience Fund NFWF, in partnership with the National Oceanic and Atmospheric Administration, released a request for proposals for the FY 2024 National Coastal Resilience Fund. Funded projects will restore, increase, and strengthen natural infrastructure—the landscapes that help absorb the impacts of storms and floods—to ultimately protect coastal communities and enhance fish and wildlife habitat. This year, the fund will invest approximately \$140 million in projects. Pre-proposals are due Wednesday April 10, 2024. Applicants invited to

submit a full proposal will have a Tuesday July 2, 2024, deadline. The complete request for proposals can be found <u>here</u>.

Environmental Protection Agency (EPA) Pollution Prevention (P2) Source Reduction (SRA) Grant

EPA funds SRA grants to support research, investigation, experiments, surveys, study, demonstration, education and training using source reduction approaches (also known as P2 or pollution prevention). EPA is particularly interested in projects that promote practical source reduction practices, tools, and training on P2 approaches to measurably improve human and environmental health by reducing the use of hazardous substances, reducing toxic pollutants, reducing resource use (e.g., water and energy) and reducing expenditures and liability costs to businesses, non-profit organizations and/or communities. NFWF America the Beautiful Challenge (ATBC)

NFWF ATBC grants support projects that conserve, restore and connect habitats for wildlife while improving community resilience and access to nature. These projects will enable states, Tribal Nations, U.S. territories, nonprofits, academic institutions, and other grantees to develop and implement multijurisdictional, high-priority restoration projects on both public and private lands. Bureau of Reclamation WaterSMART Cooperative Watershed Management Program (CWMP)The CWMP contributes to the WaterSMART strategy by providing funding to watershed groups to

USDA Emergency Community Water Assistance Grants

The USDA Emergency Community Water Assistance Grants program supports eligible communities prepare, or recover from, an emergency that threatens the availability of safe, reliable drinking water. Eligible applicants must show a decline in quantity or quality of water that occurred within two years of the date of the application or that a significant decline in quality or quantity of water is imminent. The award range is \$150,000-\$1 million. To learn how to apply, click here.

USDA Water & Wastewater Disposal Predevelopment Planning Grants

The USDA Water & Wastewater Disposal Predevelopment Planning Grants program helps eligible low-income communities plan and develop applications for proposed USDA Rural Development water or waste disposal projects. Partnerships with other federal, state and local entities are encouraged, and grants are awarded only when the applicant cannot afford to borrow the needed funds. The award ceiling is \$30,000. The GLCRS will complete a comprehensive assessment of the United States coast of the Great Lakes and connecting channels and the identification of coastal areas that could be vulnerable to future storms, flooding, extreme low or high water levels, erosion and accretion under a range of possible future climate scenarios. In April 2024, the GLCRS Team will host virtual public meetings to provide an overview of the GLCRS and solicit feedback from the public to shape a shared vision for the Great Lakes coast.
