The U.S. Environmental Protection Agency (EPA), Office of Environmental Justice & External Civil Rights Compliance, Office of External Civil Rights Compliance (OECRC), received a complaint on August 14, 2023, on behalf of the King Irving Neighborhood Association alleging Polk County, lowa, discriminated on the basis of race or national origin.

Due to the subject matter of the allegations, OECRC is referring the complaint to the U.S. Department of Health & Human Services pursuant to EPA's non-discrimination regulations, 40 CFR 7.120(d), for appropriate handling. Please contact:

Considering these circumstances, OECRC is closing this complaint as of the date of this letter. We have notified Complainant that EPA has referred the complaint to HHS for appropriate action and provided HHS with the Complainant's contact information.

EPA's regulation prohibits applicants, recipients, and other persons from intimidating, threatening, coercing, or engaging in other discriminatory conduct against anyone because they have either taken action or participated in an action to secure rights protected by the civil rights requirements that we enforce. See 40 C.F.R. 7.100. Any individual alleging such harassment or intimidation may file a complaint with OECRC.
