4. Frequently Asked Questions

Each session we like to share with everyone questions of interest or have been raised by PLC participants.

Question:

If we are a new applicant without prior job training or EPA grant history, will we be at a disadvantage when competing against experienced grantees?

Response:

EPA is interested in expanding both the applicant pool and population of recipient communities for the Brownfield Job Training Grants. Therefore, new applicants are encouraged to apply. Evaluation criteria are detailed in the Request for Applications guidelines. While the job training grant program includes past performance, evaluators recognize that some applicants may not have past performance. New applicants will not be penalized and will receive a neutral score as this part of the evaluation.

Question:

What is the time frame for receiving EPA funding to start a new job training program in our community?

Response:

Grant application, review, award, and finalization may vary but as an estimate, this is what you can expect regarding EPA's schedule for awarding FY25 Brownfields Job Training assistance.

Question:

Can an organization submit more than one application during each grant cycle serving different communities?

Response:

Applicants cannot submit multiple applications, even if the applicant proposes to serve a different target area.

5. Brownfield Job Training News

The expected criteria have been provided by EPA early so that prospective Brownfields Job Training applicants can plan accordingly. Additional details, definitions, and final criteria will be included in the FY25 Brownfields Job Training Request for Applications in early June.

Applying and reapplying for EPA JT grants- Past grantees must affirm that they do not have an open JT grant. If current EPA JT grantees with open grants



wish to reapply for an additional grant, they must demonstrate that they have drawn down and disbursed funds to at least 50% of their current grant by June 1, 2024.

Applicants will be allowed to form coalitions - Applicants may, but are not required to, propose forming a coalition to carry out their Brownfields Job Training program. Applying as an Job Training Coalition could allow the Job Training provider to recruit, train, and place students in environmental jobs, especially in rural areas where the geographic area is larger. A Job Training Coalition is comprised of one "lead" eligible entity that partners with one or more non-lead eligible entities. The lead entity is the applicant that submits an application on behalf of the coalition members, who may receive subawards.

Spring is a great time to review program plans, prepare for the next training cycle and anticipate the next round of Brownfields Job Training Requests for Applications. Currently we have 50 active Brownfields Job Training programs. Depending on each organization's situation, spring activities may vary.

Existing Grantees Funded in FY22 – There are 7 active grantees remaining with grants awarded in FY22 that were funded for \$200k over 3 years. Organizations in this group are well seasoned and have experienced the problems and benefits associated with brownfields job training. These programs have an opportunity to renew partnership relationships and consider how they may expand their program in anticipation of resubmitting an FY25 application next summer for \$500k over a 5-year period.

FY23 Grantees – 29 FY23 organizations received their authority to spend funds and are now actively training and establishing new cohorts. Special attention needs to be given to community awareness, recruitment, and student assessment.

New FY24 Job Training –The class of FY24 consists of veterans including Santa Fe Community College, City of Pittsburg California, and Great Lakes Community Conservation Corps along with several new organizations just beginning their first training cohort. The first training cohort of a new grant is the most difficult. It reveals unintended issues not previously anticipated. Hopefully with helpful tips from experienced grantees and JT-TAB assistance, recruitment, training, and placement will be successful as planned.

FY25 Prospective Job Training Applicants – Often potential applicants consider developing a job training program but procrastinate until it is too late to develop a credible program plan. Community and partner relationships take time and effort to establish. Now is the time to begin "testing the water". Begin contacting potential governmental and nonprofit organizations regarding their interest in assisting the development of a local job training program. Communities need a champion to move the concept forward and a team of volunteers willing and able to participate in the JT development process.

7. Critical Components when Implementing Successful Brownfields Job Training

Before reviewing critical components that are part of successful JT programs, stakeholders interested in training unemployed residents must determine that a need exists and there is sufficient political, community, and employer support for a JT imitative. The following steps can be taken to answer those fundamental questions.



- 1. A champion or advocate is identified who serves as program organizer, task master and perhaps project manager as the JT effort develops.
- 2. Once a project manager has been recruited, his initial task will be determining the benefits associated with JT for the communities that might be served.
- 3. The next step is the identification of resources required to implement a successful JT program. Those resources include.
 - A. Governmental support
 - B. Partnership and leveraging opportunities
 - C. Community involvement and support
 - D. The availability of project staff familiar with critical components of job training programs
- 4. After identifying program resource requirements, the project manager needs to begin identifying and recruiting program developers. Development partners will be part of a "founders working group" responsible for program planning and resource acquisition and leveraging. With a working group in place, milestones and commitments from each working partner needs to be established. Communities interested in applying for FY25 funding have a grant submission date in early August. As previously noted, FY25 applications for the Brownfields Job Training (JT) program will be issued in early June. Applicants have 60 days to prepare and submit their application. As part of their application, aspiring grantees will need to address the following issues.

Community assessment - Identifying target communities best suited for a proposed JT program

Labor market assessment - Establishing the need for locally trained and certified environmental technician graduates

Partnership development & leveraging of program resources – Partnership development

Selection of student candidates - Student recruitment, screening, and assessment

Training - Technical, life skills and remedial training

Student support - Support services, and student retention

Graduate placement - Employer screening, placement, and tracking

Program sustainability - Establishing community support and program continuation

At first glance, addressing the issues presented today can appear intimidating. Organizing a JT working group will provide sufficient time to prepare for the FY25 EPA Job Training Request for Applications (RFA). As a guide, go to the FY24 RFA. It is anticipated that there will be minor changes to this year's RFA as noted by Steve earlier in this session but generally grant evaluation criteria will be similar.

award EPA funds. This training will focus on:


Oversight responsibilities of EPA pass-through entities

- EPA's specific requirements for subrecipients

EPA pass-through entities are encouraged to share this training information with their subrecipients.
