#### 2. Brownfield Job Training News

Since the last PLC, lots has happened regarding the new round of Brownfields job training grants. Today we are going to identify numerous publications, webinars and websites that we think will be useful in developing a brownfields job training program and responding to the FY25 EPA Requests for JT Applications. #### Recent events and announcements

May 17<sup>th</sup> - EPA posted the Notice of Funding Opportunity (NOFO) on Grants.gov with a closing date of August 15<sup>th</sup>. 2024. An estimated \$14 million is available to fund cooperative agreement grants for a period of up to 5 years for a total grant of up to \$500 thousand each.

May 23<sup>rd</sup> - KSU JT-TAB hosted a webinar titled "*Establishing A Successful Brownfields Job Training Program*" *JT101* addressing critical components associated with starting and implementing a successful job development program.

June 6<sup>th</sup> - EPA presented an outreach webinar reviewing the FY25 Request of Brownfields Job Training Applications, Notice of Funding Availability (NOFO).

June 12th - KSU JT-TAB hosted a webinar titled "Tips on Writing a Competitive EPA Job Training Proposal" JT201 presenting tips for applicants as they plan and write their JT application.

#### Question:

Is there a list of past grant recipients by State available and the types of projects they've worked on?

#### Response:

#### Question:

Is there a map of where brownfields are located?

#### Answer:

The EPA Cleanups in My Community Map identifies brownfields sites <a href="https://www.epa.gov/cleanups/cleanups-my-community">https://www.epa.gov/cleanups/cleanups-my-community</a>. You can also Contact your state brownfields program. They maintain an online database of brownfields: <a href="https://java.epa.gov/acrespub/stvrp/">https://java.epa.gov/acrespub/stvrp/</a>. It is important that a brownfield site is located in the area being served as it influences the curriculum being offered.

#### Question:

How does the presence of brownfields influence curriculum?

#### Answer:

Eligible curriculum is limited to training which facilitates the inventory of brownfield sites, site assessments, remediation of brownfield sites, community involvement, or site preparation. EPA has published an extensive list of eligible training topics <a href="https://www.epa.gov/brownfields/list-eligible-and-ineligible-brownfield-job-training-courses">https://www.epa.gov/brownfields/list-eligible-and-ineligible-brownfield-job-training-courses</a>.

#### Question:

Can you target several target communities?

#### Answer:

Applicants must identify only one target area. However, a target area can be any area (e.g., county/counties, lands of Federally Recognized Tribes, several neighboring towns or cities, a district, a corridor, a shared planning area, or a census tract, etc.) that is impacted by the presence of one or more brownfield sites.

New this year, EPA will consider coalition applications that propose to serve large geographical areas, especially rural communities that include several towns and/or Tribal lands, as well as applicants able to serve sister-cities (partnerships between U.S. cities located in different states).

#### Question:

Do you anticipate this program will continue to be ongoing in FY 2026?

#### **Answer**

Yes, EPA anticipates this program will continue in FY 2026 subject to the availability of appropriations.

# Notes from the Environmental Workforce Professional Learning Community — PLC - 304 FY25 RFA Highlights and Resources

#### Question:

Now that the RFA has been posted on grant.gov, can you give me a timeline for FY25 training cycle?

#### Response:

The FY25 grant cycle timeline for each grantee will depend on the final award date and when applicants are authorized to spend funds. If grantees request funding for the full 5 years of the grant cycle, the first four years will focus on program development, training delivery and placement. A fifth year is for additional training, placement, tracking and program sustainability. Estimated milestones for the FY25 grant cycle might look like the schedule below.

#### May 17<sup>th</sup>, 2024

FY25 Brownfields Job Training Request for Applications (RFA) are posted on grants.gov

#### August 15<sup>th</sup>, 2024

Application acceptance is closed. Applicants have been given 90 days to prepare their applications

#### Early September 2024

 Applications that did not pass threshold criteria are notified in approximately 15 days that their application is not eligible to continue for review

#### November - December 2024

- Announcements of successful candidates are announced in 3-4 months
- Unsuccessful candidates have an opportunity to review their application with Regional Job Training Coordinators

#### 1st and 2nd Quarters 2025

- Grant packages are sent to successful applicants for acceptance and returned to EPA
- Work plans and grant administration is completed prior to final award (60-90 days after submitting grant package)
- Funds available for training are released before September 31st, 2025

#### 3rd and 4th Quarters 2025

Training cohorts begin with program refinements, partnership and placement development

#### 2025- 2029

- Training cohorts continue with program refinements, partnership development and placement improvements based on experience
- Training and placement progress with ACRES reporting quarterly
- Consideration regarding program expansion, improvement and sustainability continue

#### 2030

- Placement, funding development and program continuation is considered as the completion date of the grant approaches
- Final placement, tracking, program continuation plans, and grant wrap up through 2030

#### **EPA Regional Job Training Coordinators**

Organizations are advised to contact the EPA Regional Coordinators if they are planning on submitting a proposal or if they have questions regarding their eligibility to apply. Contact information can be found at the following site. Regional EPA Job Training Coordinators

While EPA Regional Coordinators are prohibited from discussing individual grant applications. They do encourage potential applicants or do the following.

- Communicate to the Regional Coordinator an interest in submitting a Brownfields JT application
- Review threshold criteria to ensure applicants qualify for funding
- Confirm questions regarding allowable and disallowed costs

#### Resources from Technical Assistance to Brownfields (TAB) providers

EPA has funded five regional TAB service organizations to provide free technical assistance to communities and tribes who are revitalizing communities via brownfields redevelopment. Regional TAB Job Training Consultants are available to review draft grant applications before they are submitted to grants.gov. To request a review, please notify your Regional TAB Point of Contact (POC) that you will be sending a draft application for review. Allow three to five days for a response and do not send applications later than August 7th. Contact information for Regional TAB POCs can be found at the KSU JT-TAB website site.

#### Platform for Exploring Environmental Records (PEER)

The <u>Platform for Exploring Environmental Records (PEER)</u> is an interactive, open-source data tool that informs brownfields redevelopment and planning decisions. The tool aggregates and displays publicly-available environmental records in an easy-to-use, accessible way. PEER provides locations in a given search area where regulated chemicals and materials are stored or handled, and a Revitalization Risk Rating (RRR) for these locations, which indicates the likelihood of encountering a release of a hazardous substance, pollutant, or contaminant on or adjacent to the associated property. Abandoned or underutilized properties with a likelihood of a such a release, or that are adjacent to these properties, may qualify as a brownfield, for redevelopment into a new use that benefits the community.

This tool may be most useful in cases where there is not a good list of known brownfields in their community, or to get a feel for how many sites pose possible environmental risks are in their community. Users can simply zoom to the area of their city they are interested in, specify the risk ratings they care about, and download a table to get a count of sites in their community. Specific ties to sites on the map with sites the community has identified as brownfields can be made to reach general inferences about the magnitude of risks posed by brownfields in their community.

#### 5. Highlights of the FY25 RFA

#### **Getting started**

EPA Job training grants need to be submitted online. Organizations thinking of applying for FY25 funding must be registered in two government systems.

- The System for Award Management (SAM.gov) registers organizations to conduct business with the U.S. Government.
- Grants.gov is the official system for managing all federal grant applications.

These two systems share information. Together, they provide access to everything needed to complete the online application process.

Individuals access both systems through a single user account which can be created when registering with SAM.gov or Grants.gov.

First, organizations must register with SAM.gov to obtain a Unique Entity Identifier (UEI). (Note that registration must be renewed annually.)

After obtaining a UEI, organizations need to designate an E-Business Point of Contact (EBiz POC). The EBiz POC is likely to be the organization's chief financial officer or authorizing official. The EBiz POC does not submit the grant application in Grants.gov. Applications are submitted by an Authorized Organization Representative (AOR) designated by the EBiz POC.

#### Tips:

- If your organization is not registered with SAM.gov or grants.gov, start the registration process now.
- If you feel you are not in a position to complete the process just described, consider partnering as a subgrantee with an organization experienced in submitting federal grants.
- Contact your organizations EBiz POC as soon as possible. The EBiz POC needs to appoint an AOR. The AOR will be the person who will be submitting the grant application to grants.gov.
- Commit the AOR to work with a schedule for grant submission before August 15th. Suggest they check to see if their account is current. Try a test run prior to grant submission.

#### **Passing Threshold Criteria**

Threshold Criteria is a "pass/fail" screening process. In order to continue with the application evaluation, applicants must pass nine threshold criteria. An explanation of each criterion is explained in the RFA section referenced. It is important to address every item. Applicants will be notified within 15 days of a "pass/fail" determination. The nine qualifying threshold criteria are discussed in section III starting on page 14 of the RFA. - **1. Applicant Eligibility** Applicants and coalition members must be eligible entities. From the list of eligible entities is provided in Section III.A.
- 2. Coalition Agreement Each non-lead coalition member must submit a signed letter to the grant applicant in which they agree to be part of the coalition. If the application is not a coalition respond with "not applicable".
- 3. Demonstration that Proposed Project Does Not Duplicate Other Federally Funded Environmental Job Training Programs - Applicants must demonstrate that the proposed training project does not duplicate other EPA, National Institute of Environmental Health Sciences (NIEHS) or Department of Labor (DOL) programs in the target community. Links to those programs are on pages 17 and 18 of the RFA.
- 4. Required HAZWOPER Training The application must document that OSHA 29 CFR § 1910.120 40-hour Hazardous Waste Operations and Emergency Response (HAZWOPER) training will be included in the training curriculum and be provided to all trainees. Include the page in the Narrative where this information can be found.
- **5. Federal Funds Requested and Estimated Project Period** Indicate the requested funding amount and estimated project period not to exceed 5 years and \$500,000.
- **6.** Substantial Conformity with Instructions and Format Requirements Confirm that the application conforms to the application submission instructions and format requirements (page counts, no photos, font type and size etc.).
- 7. Training Curriculum Chart Indicating the Cost of Each Course The training curriculum chart with associated costs for each training course must be included with responses to the ranking criteria as part of the Narrative. Indicate on which page of the Narrative the training curriculum chart can be found.
- **8.** Target Area Identify one target area to serve including a county or counties, Tribal lands, a number of neighboring towns or cities, a district, a corridor, a shared planning area, or census tract data. Indicate on which page of the Narrative detailed information can be found.
- **9. Previous Funding Requirement** Confirm that an EPA Brownfields Job Training grant was not received in FY24.
- **10. Expenditure of Existing Brownfields Job Training Grant Funds** Affirm that an EPA Brownfields Job Training Grant is not open. Current EPA Brownfields Job Training Grant recipients must demonstrate that drawn down funds have been disbursed, for at least 50.00% of the funding by June 1, 2024.

#### Tips:

- Submit Threshold Criteria to EPA Regional Job Training Coordinators if there may be issues regarding application eligibility. While Regional Coordinators are not able to discuss specific grants, they can review and answer questions regarding the Threshold section of applications and clarify guideline questions.
- The project period can be less than 5 years and less than \$500,000.
- If the application is not a Brownfields Job Training Coalition or previous grantee, state 'n/a' or 'not applicable'.
- Additionally, respond to every threshold criterion indicating "not applicable" when appropriate.
- If a grant has not been received in the past, be sure to also state this in the narrative.
- Cost sharing and matching funds are not required. Voluntary cost share will not be accepted.
   Contributions from applicants should be included with leveraged funding.
- The training curriculum chart with associated costs for each training course must be included with responses to the ranking criteria as part of the Narrative. When addressing this threshold criterion, indicate on which page of the Narrative your training curriculum chart can be found.

#### **Developing the Narrative Information Sheet**

The Narrative Information Sheet provides an introduction to the project. It is limited to 3 pages and should be printed on your organization's letterhead. The Narrative Information Sheet is not a summary or overview of the project. EPA does not consider information in the Narrative Information Sheet to be responses to the evaluation criteria. The 3-page narrative information sheet should include the following information

- 1. /Target Area Data Application Identification Name address etc.
- 2. Grant type "Brownfields Job Training Grant" or "Brownfields Job Training Coalition."
- 3. Project Period and Funding Request Up to 5 years and up to \$50,000.
- **4. Coalition Members** Indicate "not applicable" when appropriate.
- **5. Training program website** If selected for funding, EPA will include the links to the social media accounts on the Brownfields Grant Factsheet Tool.

#### 6. Population

- Provide the general population of the area you are proposing to serve and the population of your defined target community.
- Identify the target area discussed in the Narrative.
- If the target area is smaller than a city/town, list the eleven-digit census tract number(s) within the target area.
- Identify where the training facility will be located.

#### 7. Contact Information

- Project Director assigned to the proposed program and may be contacted if additional information is required.
- Chief Executive/Highest Ranking Official who may also be contacted if additional information is required.

#### **Developing the Narrative Information Sheet** (Continued)

- **8.** Releasing Copies of Applications Indicate which portion(s) of the application are confidential, privileged, or sensitive information, or state 'not applicable' if the application does not have confidential, privileged, or sensitive information.
- 9. Other Factors: Evaluators may consider Other Factors in making their final funding decisions. Applicants should identify applicable Other Factors and note the corresponding page number where Other Factors are discussed in the Narrative section of the application. Other factors include the following.
  - Whether the community population is 10,000 or less.
  - Whether the applicant has not received an EPA Brownfields Job Training Grant since 2015.
  - Whether the applicant is a federally recognized Indian Tribe or United States territory or whether the project is assisting a tribe or territory.
  - Whether the applicant is seeking to serve veterans.
  - Whether a target area is located within a community in which a coal-fired power plant has recently closed (2015 or later) or is closing.
  - None of the above

#### Tips:

- Many JT programs seek to serve veterans. Consider how a recruitment plan would include opportunities for exiting the military.
- While not part of Other Factors, issues such as proposed programs located within an area experiencing persistent poverty or programs addressing populations with special needs such as returning citizens should be noted in the narrative.
- Additional consideration is given to the distribution of funds among EPA's ten regions, new applicants, rural and tribal applicants, and coalition grants.

#### **Writing the Narrative**

Writing the narrative is essentially responding to Ranking Criteria which total 200 evaluation points. As previously noted, every request for information must be addressed. Failure to respond may result in a lowered score for the criteria in question. When combined with other evaluation considerations, applications with the highest scores will be considered for funding.

#### **Attachments**

Attachments include letters of support from community organizations, environmental partners, leveraging resources, and potential employers. Contributions from organizations noted in the Narrative should provide a letter of support or Memorandum of Understanding (MOU) elaborating their commitment to the program. Attachments should also include a milestones schedule indicating start times and completion dates of significant tasks under the program including the following.

#### Tips:

- Never use repetitive or form letters of support to be signed and returned
- Personally contact partners providing letters of support
- Obtain specific commitments and MOUs when applicable

#### COMMUNITY CHANGE EQUITABLE RESILIENCE TECHNICAL ASSISTANCE

EPA has launched a technical assistance program to help disaster prone and disadvantaged communities prepare to apply for Community Change Grants. The Community Change Equitable Resilience program will provide free design and project development assistance, community engagement, and partnership development workshops.

Climate resilience projects that qualify for technical assistance include a focus on new or expanded green infrastructure, open spaces, and/or retrofits of existing community buildings or streets to address climate change impacts (such as extreme heat and more intense heat islands, wildfire and smoke, floods, storms, or other climate impacts that pose a greater risk to disadvantaged communities).

# Office of Environmental Justice and External Civil Rights (OEJECR) EPA Community Change Grants are NOW OPEN

EPA's new Environmental and Climate Justice Community Change Grants program (Community Change Grants) is now OPEN with approximately \$2 billion dollars in Inflation Reduction Act funds in environmental and climate justice activities to benefit disadvantaged communities.



# Inflation Reduction Act Environmental and Climate Justice Program

The Environmental and Climate Justice Program (ECJ Program), created by the Inflation Reduction Act (IRA) under Clean Air Act (CAA) Section 138, provides funding for financial and technical assistance to carry out environmental and climate justice activities to benefit underserved and overburdened communities. EPA has created the <a href="EPA IRA Disadvantaged Communities map">EPA IRA Disadvantaged Communities map</a> layer to assist potential applicants seeking to identify whether a community is disadvantaged for the purposes of implementing programs under the IRA.

Congress has appropriated \$2.8 billion for financial assistance, and \$200 million for technical assistance, to implement this new program at the EPA. EPA must award grants and technical assistance under the ECJ Program by September 30, 2026.

# The Susan Harwood Training Grant Program Occupational Safety and Health Administration

The Susan Harwood Training Grant Program was created in 1978 to provide funding to nonprofit organizations to develop and deliver training to small business employers and workers on the recognition, avoidance, and prevention of occupational safety and health hazards in their workplaces and to inform workers of their rights and employers of their responsibilities under the OSH Act. Three different grant types are available: Targeted Training Topic; Training and Educational



Materials Development; and Capacity Building. Applicants are encouraged to provide training in languages participants can understand. Training materials developed under this grant program are made publicly available on the OSHA webpage.


