During open solicitation, EPA personnel may respond to questions regarding threshold eligibility criteria, administrative issues related to the submission of the application, and requests for clarification about the announcement. However, EPA personnel cannot meet with individual applicants to discuss draft applications, provide informal comments on draft applications, or provide advice to applicants on how to respond to Narrative/ranking criteria. CCLR personnel can review and provide comments on draft applications, including responses to the Narrative/ranking criteria.

FY 2025 Brownfields Grant Types

NO COST SHARE – while BIL funding is available

Community Wide Assessment (CWA)

- Brownfields inventory, Phase I/II environmental site assessments, community engagement, cleanup/reuse planning.
- \$500K

CWA for States and Tribes

- Brownfields inventory, Phase I/II environmental site assessments, community engagement, cleanup/reuse planning.
- \$2M only available to States and Tribal Nations
 Assessment Coalition
- Brownfields inventory, Phase I/II environmental site assessments, community engagement, cleanup/reuse planning.
- \$1.2M one lead member, 2-4 partners

Cleanup

- Remediation, reuse planning, regulatory oversight fees.
- \$500K, \$2M, and \$4M
- Applicant must be owner of the site, completed a Phase II ESA, not considered RP

Revolving Loan Fund

- Funding to support brownfields cleanups through low/no interest loans and subgrants
- \$1M + supplemental funding over time
- Applicant must be able to manage loans and subgrants (priv. owned sites can receive loans)









NOFO Changes

- Multipurpose Grants are NOT being offered this year.
- 2. Tribes are no longer required to follow federal procurement guidelines.
- 3. Entities that were awarded a FY22-24 CWAGST are not eligible to apply for Coalition or CWA in FY25.

- Drawdown requirements must be met by Oct. 1st, 2024. CWAGST applicants must have drawn down 60% reduced from 70%
- 5. Coalition applicants must have at least one non-lead member who has never had a MARC grant.
- 6. Section for Cleanup applicants to demonstrate eligibility for a site with HBM that has not been released outdoors.




CEJST (Climate and Economic Justice Screening Tool)

- 4. Reports and Findings from Previous Audits
- 5. Ability to effectively implement statutory, regulatory, or other requirements imposed on non-Federal entities.

Verifying Capability after Award Recommendation

- 1. Fill out EPA Form 6600-09
- 2. Potential for pre-award or special conditions.

- ☐ Applicant must be an eligible entity (State, Tribe, Local Gov, Non-profit)
 - □If applicant is a non-profit entity, must attach your taxexempt status

Cleanup Grant Pre-Application Requirements

- ☐ Completed Phase II Environmental Site Assessment (or equivalent report)
- ☐ Draft Analysis of Brownfields Cleanup Alternatives (ABCA) report or equivalent document
- Letter from State or Tribal Environmental Authority -ensuring that the site is sufficiently characterized and the status of the site in the state or Tribal voluntary response program.
- □ Release a Community Notification Ad must be placed no later than 14 days before application submission (Nov. 14th, 2024)
- ☐ Host a Public Meeting must be held to discuss and consider comments on the Cleanup Grant application and draft ABCA. Applicants must be able to demonstrate how this feedback was considered.

- Conducting economic market and feasibility analysis for brownfields properties.
- Helping practitioners assess and analyze existing plans and conditions to inform areawide redevelopment plans.
- Evaluate the potential reuse of existing infrastructure; and identify sites that can help spur revitalization and economic development.

Redevelopment Financing; Grant Prep/Management; Procurement

- Identifying funding opportunities and creative financing approaches.
- Developing redevelopment roadmaps and funding matrices.
- Providing guidance during brownfields grant application preparation.
- Providing thorough review of draft grant applications.
- Supporting grant management and programmatic activities including quarterly/annual reporting, understanding and inputting data into ACRES, and reimbursements through ASAP.
- Assisting with understanding your Cooperative Agreement (CA) and Workplan.
- Assisting with and navigating the procurement process.
- Developing RFPs and RFQs including evaluation criteria and process of selecting contractors or consultants.

Remediation Support

- Procuring a contractor to conduct environmental site assessments and due diligence.
- Interpreting environmental technical reports including remedial investigations, Phase I and Phase II environmental site assessments, analysis of remediation alternatives, feasibility studies, and cleanup plans.
- Navigating and interpreting regulatory requirements by facilitating conversations with applicable state agencies.
- Understanding voluntary cleanup programs and their requirements.
- Assessing potential risk and liability associated with a brownfield property.

Stakeholder Engagement

- Facilitating and planning community involvement activities and developing community engagement plans.
- Helping practitioners communicate the reuse process, risks, and benefits to community stakeholders.
- Connecting and convening the community with other relevant stakeholders and practitioners including agency officials, consultants, attorneys, and more.
- Assisting with marketing sites, including developing Property Profile Sheets, to third parties interested in purchasing properties.


