This letter is to advise you that the U.S. Environmental Protection Agency, Region 7, has completed its review of information collected during an on-site inspection of Kinder Morgan Transmix Company, LLC (Kinder Morgan) located at 4070 South 1st Street, St. Louis, Missouri, on September 26, 2023. Based on our review, we have determined that no violations were identified in the information collected or observed during that inspection. However, the EPA notes that possible emissions were observed at the process heater for the distillation column (EU-33) using the forward-looking infrared camera. The Agency encourages you to take all necessary steps to minimize potential emissions.

The inspection of Kinder Morgan was conducted pursuant to Section 114 of the Clean Air Act, 42 U.S.C. § 7414. Section 114 of the CAA authorizes the Administrator of the EPA or his authorized representative, upon presentation of his credentials to have a right of entry to, upon, or through any premises of such person or in which any records required to be maintained are located, and may at reasonable times have access to and copy any records, inspect any monitoring equipment or method required under § 7414(a)(1), and sample any emissions which such person is required to sample under 42 U.S.C. § 7414(a)(1).

Kinder Morgan owns and operates an emissions source and is required to maintain records and/or monitoring equipment under 42 U.S.C. § 7414(a)(1). The inspection was conducted to determine if Kinder Morgan was in compliance with the CAA.

No further action on the part of Kinder Morgan is necessary at this time. Although no violations were identified and we are closing our investigation, please note that the EPA reserves its right to pursue appropriate enforcement actions, including penalties, for violations discovered as a result of this

inspection, regardless of whether the violations were subsequently corrected.
