Empire ~~Leaseholder Wind Offshore~~, LLC is hereby authorized to construct and operate an offshore wind farm project located on the OCS within the lease area OCS-A 0512 at about 12 nautical miles (“nm”) south of Long Island, New York, and 17 nm east of Long Branch, New Jersey. The construction and operation of the wind farm shall be subject to the attached permit conditions and permit limitations.

XIV. GENERAL REQUIREMENTS

19. Recordkeeping Requirements.

- b. This permit or a copy thereof shall be kept at the office of Empire Leaseholder Offshore Wind, LLC, which is located at the address specified on page 1 of this permit.

[c. remains unchanged]

- d. The Permittee shall hold at the office of Empire Leaseholder Offshore Wind, LLC, which is located at the address specified on page 1 of this permit, all records required by the permit including, but not limited to, monitoring data and support information required by the permit, and records of all data used to complete the application for this permit. These materials shall be retained for at least five years from the date of the sample, measurement, or report unless otherwise specified. Records of all data used to complete the permit application must be kept for five years from the date of the application, unless otherwise specified. Support information includes all calibration and maintenance records and all original strip-chart recordings for continuous monitoring instrumentation and copies of all reports required by the permit.
