3. Briefly explain the need for a waiver:

Garney had released a 36" slanted disc check valve from DeZurik on December 15th 2023 with the contractual delivery date of 11/25/24. During assembly of the valve, it was discovered there was a defect in the valve casting, and a new valve would have to be recast. Due to this defect,

the new anticipated delivery date of the valve is March 26th of 2025. This valve is scheduled to be installed the second week of January 2025 during a critical shutdown.

A similar 36" check valve manufactured by Pratt has been located, and is readily available for shipment, however it is not AIS compliant. Due to the critical shutdown being completed in the dry season, and the consent decree on the job, this waiver is needed to maintain the project schedule.

The following manufactures were reached out to regarding availability of a 36" ductile check valve, all of which has no available AIS or Non-AIS compliant valves, less Pratt which the waiver is being submitted for. GA Industries, McWane, Valmatic, Pratt, DeZurik, AFCO.

This waiver is being requested for a Pratt 36" Series 8001 AWWA Swing Check Valve, due to the unforeseen casting issue of the originally AIS compliant DeZurik slanted disc check valve that was intended for this application. This valve is scheduled to be installed during a critical shutdown during the dry season on 1/15/25. Waiting for the AIS compliant valve would significantly delay the project as the new anticipated delivery date is March 26th 2025 and we

are unable to install until the dry season in the fall of 2025 and startup of the new plant is Scheduled for June 2025.
