# **OECA OVERVIEW**

## **Description/Responsibilities**

The Environmental Protection Agency's (EPA) Office of Enforcement and Compliance Assurance (OECA), located at EPA Headquarters (HQ) in Washington, DC and throughout EPA's 10 regional offices protects human health and the environment through vigorous civil and criminal enforcement that targets the most serious water, air, and toxic chemical hazards. OECA and the Regions ensure that the regulated community complies with the laws and regulations designed to protect public health and the environment, thus assuring that EPA delivers on the protections promised by those laws and regulations. Regions coordinate with their state, local and tribal counterparts to promote effective partnerships in enforcement and compliance assurance work between EPA and states, tribes, and territories that are authorized to implement federal programs.

- Locations: In addition to its HQ and regional offices, OECA has criminal investigators stationed in 43 offices

  the National Computer Forensics Laboratory, Jacksonville, FL. OECA also houses the National Enforcement
  Investigations Center in Denver, CO.

- Regional Staff: The Program includes ~1,860 Regional Staff, including ten Regional Counsels who report directly to both OECA and the Office of General Counsel.

- Federal Facilities Enforcement Office (FFEO) Ensures that federal facilities take all necessary actions to
  prevent, control and abate environmental pollution. FFEO achieves compliance at federal facilities under all
  environmental regulatory and cleanup statutes through inspections, enforcement, interagency partnering, and

- Office of Civil Enforcement (OCE) -Sets direction for the civil enforcement program, which includes all
  environmental statutes except CERCLA. OCE develops and prosecutes civil administrative and judicial cases and
  provides legal and technical support for cases and investigations initiated in EPA regions. OCE sets and manages
  national enforcement priorities, develops national enforcement policy and guidance, advises the OECA AA on
  tribal enforcement matters, and works with other headquarter offices to ensure new regulations are

- Office of Site Remediation Enforcement (OSRE) Maximizes responsible party contribution in performing and funding contaminated CERCLA sites cleanup while ensuring national consistency by developing policies and guidance. OSRE provides legal and technical partnership and support on highly complex negotiations, settlements, orders, and judicial proceedings to EPA regional offices. - Office of Criminal Enforcement, Forensics and Training (OCEFT) Investigates criminal violations of environmental laws, provides a range of technical and forensic services for both civil and criminal investigations, and provides legal counsel support on criminal cases. - Office of Administration and Policy (OAP) Provides enforcement policy, administrative, and management coordination across OECA including human resources, labor relations, budget, finances, contracts, grants, records management, and information technology.
