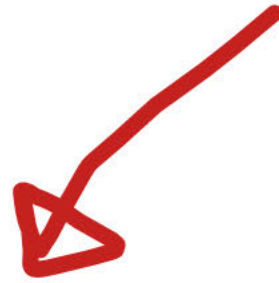

*FLINT, Mich. (WNEM) – Flint City Council approved
the allocation of \$4 million to be used for sidewalk
repairs and right-of-way tree maintenance in Flint
neighborhoods this summer.*

The city of Flint said an assessment of all its sidewalks is underway to identify the areas that are in most need of repair, and some trees that are in the city-owned right-of-way and are damaging the sidewalks will be maintained or possibly removed.

According to the city, its goal is to improve pedestrian safety, the appearance of neighborhoods, and the quality of life for residents.

The work is part of Mayor Sheldon Neeley's Safe and Clean Summer initiative, the city said, adding it is ensuring sidewalk repairs happen in every city ward."

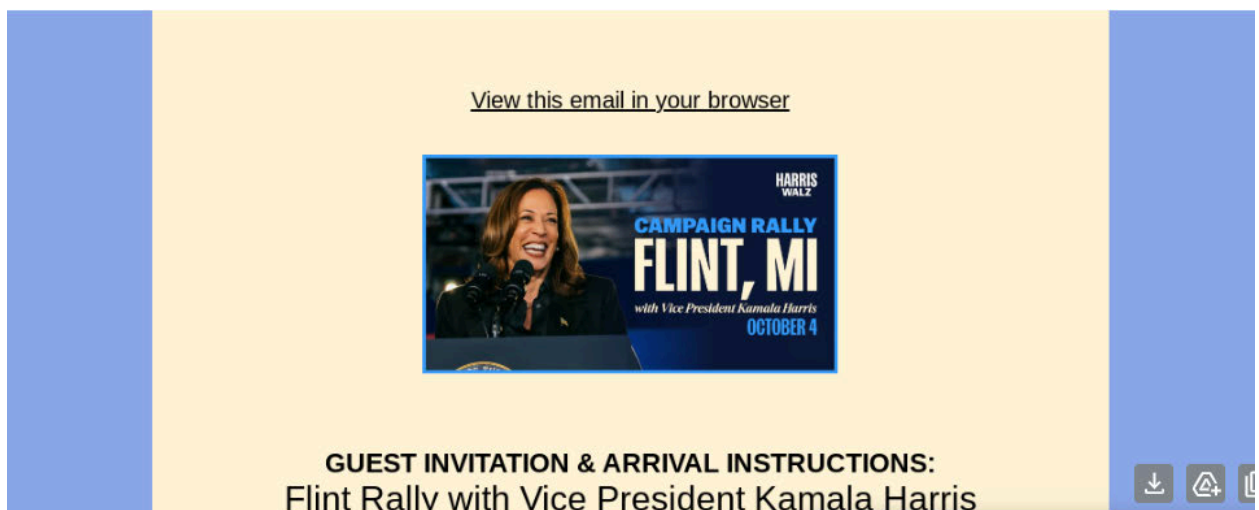

Simply put... yesterday --- as I was tidying up the front yard and my front door ...[such] literally caused my disabling medical conditions to be WORSENER today; such that getting to said "event" today is NOT possible for me; yes... even my intestinal area hurts near my lower back, and my knees are torn up real bad... which is to say my indoor/ outdoor walker does NOT help much when it is this bad of a health day for me... because said walker[s] are primarily due to unsteadiness on my feet. However, I do have a disabled persons parking placard issued by the State of Michigan {e.g. but my necessary support person would have had to drive me to such anyway}... and I RARELY leave my home due to my disabling medical conditions; AND THE STATE OF MICHIGAN, CITY OF FLINT, and CITY OF FLINT BLIGHT ELIMINATION DEPARTMENT and GENESEE COUNTY LAND BANK have

literally purposely FAILED/ refused to repair the outrageously NON-ADA public sidewalk which abuts the front yard of my home... So this is YET ANOTHER reason (e.g. as a disabled person) I am NOT able to get over to the DORT center [e.g. which is literally less than 1 mile from my home in Flint, Michigan]... sad but true.

And --- PLEASEif you can tell Kamala Harris to BE VERY RELAXED and to REMEMBER to wear her cool converse tennis shoes and maybe even DRESS DOWN... in a MORE relaxed fashion... {e.g. cool blue jeans and white long sleeve shirt}... such as what the Michigan Lt. Governor Gilcrist wore when he was a panel person along with VP Harris' sister a week or so ago. YEP - a very classy, but understated look {e.g. the City of Flint is a "financially distressed City"}.

SUBJECT: Management Implication Report: The EPA Did Not Properly and Timely Disclose Fraud in its Programs and Operations

FROM: Sean W. O'Donnell, Inspector General *Sean W O'Donnell*

TO: Michael S. Regan, Administrator

Purpose: The U.S. Environmental Protection Agency Office of Inspector General has identified a concern regarding the EPA's obligation to properly and timely disclose fraud to the OIG. A failure to disclose fraud, waste, and abuse, or other potential improper or illegal conduct involving an EPA program or operation, can negatively impact the EPA's ability to fulfill its mission and ensure the soundness of, and confidence in, the EPA's programs and operations. Moreover, this places the public's health at risk and diminishes the trust in, and resiliency of, the EPA's programs and operations. This report addresses the concern that the EPA did not properly and timely disclose fraud in the EPA's programs and operations, which weakens the OIG's ability to fulfill our fraud fighting mission and places in jeopardy the success of the EPA's public health mission. We conducted this investigation in accordance with the *Quality Standards for Investigation* published in November 2011 by the Council of the Inspectors General on Integrity and Efficiency, as well as our internal standards. These standards require that we conduct investigations in a timely, efficient, thorough, and objective manner.

Background: According to the Inspector General Act of 1978, as amended, 5 U.S.C. §§ 401–424, the OIG is charged with preventing and detecting fraud, waste, and abuse related to the programs and operations of the EPA and the U.S. Chemical Safety and Hazard Investigation Board. To this end, the OIG's Office of Investigations has responsibility for "conduct[ing], supervis[ing], and coordinat[ing] ... investigations relating to the programs and operations of the [EPA and the CSB]," according to 5 U.S.C. § 404(a)(1).

As set forth in Basic obligation of public service, 5 C.F.R. § 2635.101, "employees shall disclose waste, fraud, abuse, and corruption to appropriate authorities." Further, 40 C.F.R. § 13.5, Claims involving criminal activities or misconduct, states that "The Administrator will refer cases of suspected criminal activity or misconduct to the EPA Office of Inspector General." This is consistent with the long-standing policy of the EPA to "require that all employees promptly report instances of, and information on, any known or suspected violation of law, rules, or regulations; mismanagement; gross waste of funds; abuse of authority; or substantial and specific danger to the public health and safety ... to their supervisors or,

1.) PLEASE ALLOW ME (e.g. as a disability accommodation) AT LEAST UNTIL this coming Friday or Monday to send to the US EPA Title VI department what will/ is my ultimately "SUPPLEMENTED" and FINAL US EPA Title VI discrimination complaint;

2.) please take special notice - that said NEW Title VI discrimination complaint will be asserted against [a.] The Genesee County Land Bank, (b.) the City of Flint, and {c.} the State of Michigan [and] (d.) the City of Flint (state of michigan local unit) - Blight Elimination Department;

3.) For example... [I] have been given the "N*GGER" treatment by the Genesee County Land Bank on two occasions {e.g. lets keep in mind also that the GCLBA has a history of RACISM and outright calling Black African Americans like me a "N*GGER" - and a few lawsuits PRO SE ...[I] might add, have been filed in Federal Court against the GCLBA by disabled and Black Flint residents}... the first was when the GCLBA sold me a vacant lot @ (b)(6) Privacy, (b)(7)(C) Enf. Privacy - Flint. Said vacant lot was UNKNOWN to me and NOT disclosed to me to be that of a health hazard - brownfield lot when the GCLBA sold it to me... I am only became aware if such ACCIDENTALLY when the GCLBA "on the sneak" changed the deed to that of BROWN FIELD... and I have NEVER since then gone to said lot via (b)(6) Privacy, (b)(7)(C) Enf. Privacy driving to such. The 2nd occasion when the GCLBA treated me like a "N*GGER" is when they along with the City of Flint sold me my home (b)(6) Privacy, (b)(7)(C) Enf. P

Flint, Michigan 48503)... on November 28th, 2028. **Whereby on October 1st, 2024... I have NOW discovered and such is the ACTUAL date of discrimination put against me on account of the GCLBA and City of Flint and Flint Blight Elimination departments' racist views of me being a disabled "N*GGER" (i.e. which they all attempted to cover up from the US EPA and US EPA OIG and [me]).... that the LEAD BASED PAINT hazard and toxic mold CANNOT be remediated as to my home without EXTENSIVE "destruction" of the supporting "wall" which supports the FIREPLACE of my home {e.g. making it UNSAFE for me to literally use the FIREPLACE of my home due to such}... because of**

"release" of LEAD BASED PAINT into the AIR outside through the chimney of the fireplace in my home;

*4.) On or about September 2024... the walker wheel of my outdoor walker became broken DUE TO ME HAVING TO TRAVERSE THE NON ADA COMPLIANT PUBLIC SIDEWALK WHICH ABUTS THE FRONT YARD OF MY HOME, and leads up to the CEMENT WALKUP the front door of my home... and that was (I believe) due to the GCLBA, City of Flint and City of Flint Blight Elimination departments' RACIST and ANTI-DISABLED bigotry of seeing me as a disabled "N*GGER"... and therefore NEITHER the City of Flint, nor the GCLBA nor the Flint Blight Elimination department (on or about September 2024) cared to stop their intentional racist and anti-disabled discrimination against me by simply*

REPAIRING the NON-ADA compliant PUBLIC right-of-way SIDEWALK {which they own along with the State of Michigan}... which abuts the front yard of my home @ (b)(6) Privacy, (b)(7)(C) Enf. Privacy Flint, Michigan.... NONE of the named respondents herein put to good use the \$ 14 million dollars of FEDERAL FUNDS which Flint Mayor Sheldon Neeley (wrongly) transferred to the GCBLA ...whereby said Federal Funds are and have been used to 'subsidize' RACE and DISABILITY discrimination against BOTH (b)(6) Privacy, (b)(7)(C) Enf. Privacy {e.g. on account of (b)(6) Privacy, (b)(7)(C) Enf. But the difference here with me is -- I HAVE TAKEN THE TIME TO SEEK ONGOING AND GOOD QUALITY HEALTH CARE.... and have NOT (and

PRAISE JESUS thankfully WILL NOT).... take care of the City of Flint and State of Michigan public right of way property which abuts the front yard of my home (e.g. notwithstanding the neighbors vicious pit bulls being set upon BOTH [REDACTED] and I [and] the City of Flint purposely NOT collecting water bills ...which NO DOUBT put an undue burden upon the LATE Mr. Quincy Murphy as to him doing what the GCLBA and the State of Michigan and City of Flint should have been doing.... SO YEAH --- I bet they will miss Councilman Murphy powerful bad)....

And, what will change - ANSWER: NOTHING... the GCLBA and City of Flint (e.g. Mayor Sheldon Neeley) and the State of Michigan will still go about and ALLEDGE that they are "getting things done"... while wasting and misspending US EPA funds... and discriminating against the Black Disabled folks in the City of Flint [e.g. such as myself].

**** SUPPLEMENTED ALLEGATION[s]
OF DISCRIMINATION/ RETALIATION
by the City of Flint and State of
Michigan on August 12th, 2024 and
August 13th, 2024 ******

*On August 13th, 2024 the City of Flint and
State of Michigan were fully aware that an
order was SOON to issue from U.S.
District Court Judge Judith LEVY which
(in subtle but meaningful ways) would
“finally” and fully SHIFT the BLAME for
the origins and aftermath of the Flint*

Water Crisis FROM the State of Michigan and City of Flint... to the US EPA in its context and PUBLIC view “implications” regardless of the outcome of the FWC BW 3 trial. And, it was suspected at the time by the City of Flint and State of Michigan that [I] was somehow being “PAID” by both the US EPA and VNA (Veolia North America) as some sort of “local citizen council” for helpful observational informal gleaned by me as to the City of Flint. And, so - on said date, August 13th, 2024, the City of Flint (acting in concert with the State of Michigan) ...sent TWO (white men) over to my home — with the GOAL of intimidating me into “CONFESSING” that the US EPA was going to SEND A TESLA CAR TO ME for [REDACTED] to own; YES -

and the issue that “got the discriminatory and racist” ball rolling is that AS A FUN SIGN... and to UPLIFT myself - I put up a TESLA PARKING ONLY SIGN IN MY FRONT YARD... and A FAUX ELECTRIC CAR CHARGING PORT... as sort of a way to “come into agreement with God and Joel Osteen... that SOON TESLA will release a FULLY autonomous self driving car that is also a FULLY electric car. YES - [I] think that Elon MUSK (regardless of his politics) is an exceptional talent which is GREATLY overlooked by the ENTIRE Democratic party {e.g. see the documentary on NETFLIX “return to space”}.

And... so to “get the information” on WHEN the TESLA CAR was set to be

delivered... the TWO - City of Flint police detectives put forth FABRICATED reasons for being at my home... whereby the REAL reason for such was to RETALIATE against me for my participation in the instant US EPA TITLE VI complaint process {e.g. discriminate against me, and (b)(6) Privacy, (b)(7)(C) Enf. Privacy and intimidate me on account of my having reached out to the US EPA Title VI Department and my ongoing EMAILS sent to the US EPA Title VI department as of August 12th, 2024}... so that [I] would become scared and afraid of further retaliation and simply NOT participate in the US EPA Title VI process anymore... and I must say - it did work for a while... and a STILL today feel intimidated and scared to go forward as to the US EPA Department Title VI “ongoing”

jurisdictional review - but through PRAYER ...[I] will find the strength to carry on with my participation in the US EPA Title VI process here...

An ADDITIONAL “goal” of the City of Flint and State of Michigan’s 8-13-2024 discrimination, retaliation and intimidation put against BOTH (b)(6) Privacy, (b)(7)(C) Enf. Privacy and me was to HIDE and COVER UP the following:

A.) Water and Sewage Department (“DWSD”) to water from the Flint River provided through the Flint Water Treatment Plant. Unlike Lake Huron Water, Flint River water was seriously corrosive (especially without the use of corrosion inhibiting orthophosphates) and

caused lead to leach from the pipes, internal plumbing fixtures, and service lines into the public drinking water supply; and MANY folks in the City of Flint and State of Michigan [WHO UNLIKE THE US EPA and VNA, and LAN and WELLS FARGO BANK, et al] HAD LOCAL LAW ENFORCEMENT JURISDICTION TO IMMEDIATELY PUT A STOP TO THE FLINT WATER CRISIS and “WARN THE PUBLIC OF THE KNOWN DANGERS OF THE FLINT RIVER BEING A DRINKING WATER SUPPLY FOR THE CITY OF FLINT; and WARN OF THE ONGOING DAMAGES AND HARM THAT SUCH WOULD CAUSE TO HOMES OWNED BY THE GENESEE COUNTY LAND BANK AUTHORITY {e.g. such as then -
(b)(6) Privacy, (b)(7)(C) Enf. Privacy - Flint, Michigan 48503}...

but purposely (as a means of unlawful discrimination against the “already brain damaged” disabled folks in the City of Flint such as myself {e.g. my history of CVA - STROKE, and CLOSED HEAD INJURY DUE TO FALL[s]}). Intentionally FAILED to ADEQUATELY WARN ME of said known dangers - to wit: MDCR literally ate donuts and drank coffee while they wrote a report when they instead could have stopped the Flint Water Crisis by sounding the warning whistle. This is to say that a report is not going to replace the plumbing in
(b)(6) Privacy, (b)(7)(C) Enf. Privacy
house. MDCR was in a perfect position to sound the warning whistle and stop the Flint Water Crisis. Instead, however, they simply talked

*and counted emails; additionally -
Genesee County and Genesee
County Land Bank, Genesee County
Sheriffs Department and the City of
Flint Police department, and multiple
State of Michigan agencies and
departments and for that matter the
City of Flint Fire Department and City
of Flint Blight Elimination Department
ALL could have and should have
spoken up to STOP the Flint Flint
Crisis, but FAILED to do so - because
it was much more comfortable not to
alert the public of the known dangers
of the corrosiveness of the Flint River.*

B.) Water and Sewage Department (“DWSD”) to water from the Flint River provided through the Flint Water Treatment Plant. On August 13th, 2024 the City of Flint Blight Elimination Department and the City of Flint sent TWO caucasian male police officers in PLAIN clothes driving a greenish Honda Accord [e.g. as best that I can recall]... and they parked abruptly in front of my home, but sort of across the street as I sat on my outdoor walker while (b)(6) Privacy, (b)(7)(C) Enf. Privacy">[REDACTED] was digging up some dirt to clean out a metal planter box which was in need of being removed.

I remember that the younger looking officer did NOT identify himself; but the

older officer later identified himself as a Flint Police Detective - in fact I believe that his “business card” says OFFICER/ DETECTIVE [REDACTED].

I believe that their stated reason and actual reason for having stopped by my home was COMPLETELY MANUFACTURED, and the reason for officer [REDACTED] asking for “something with my signature on it” was manufactured also. The main point of the discrimination put against me by the Flint Blight Elimination department/ City of Flint on August 13th, 2024 was ANTI-SEMITISM against [REDACTED] [i.e. whom is a JEWISH person - and the City of Flint/ Flint Blight

Elimination Department is well aware of that fact prior to August 13th, 2024]. 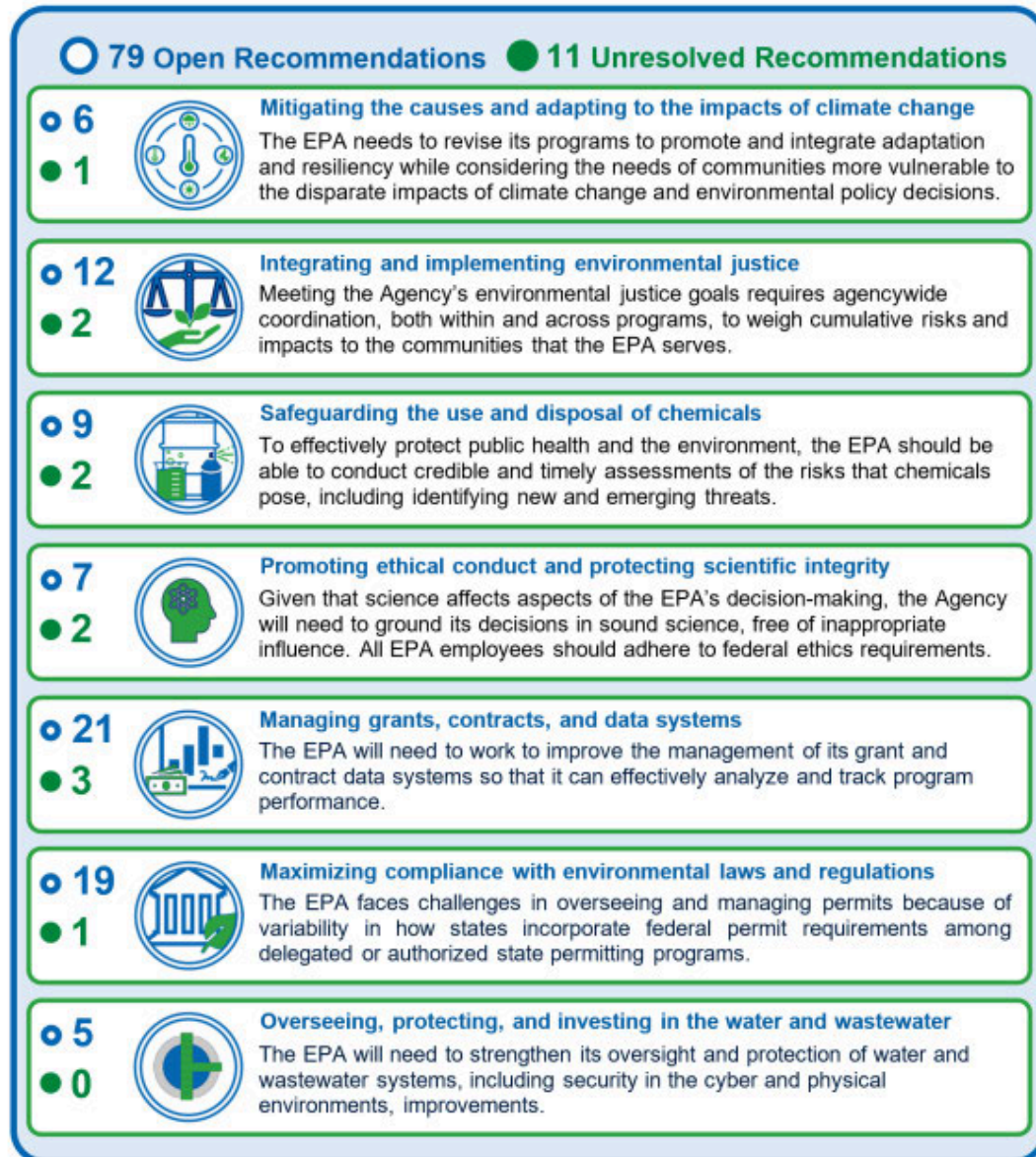

We also highlight five recommendations to the U.S. Chemical Safety and Hazard Investigation Board, or CSB, that remain unresolved.

The Inspector General Act of 1978, as amended, requires each inspector general to prepare semiannual reports for Congress, which must include "an identification of each recommendation made before the reporting period, for which corrective action has not been completed, including the potential costs savings associated with the recommendation." This compendium provides further analysis of open recommendations identified in Report No. [EPA-350-R-24-001](#), *Semiannual Report to Congress: October 1, 2023–March 31, 2024*, issued May 2024.

Section 1 outlines how open and unresolved recommendations relate to the Agency's key management challenges, which we detail in Report No. [24-N-0008](#), *The EPA's Fiscal Year 2024 Top Management Challenges*, issued November 15, 2023. Section 2 identifies the high-priority open or unresolved recommendations. Section 3 focuses on unresolved recommendations to the EPA. 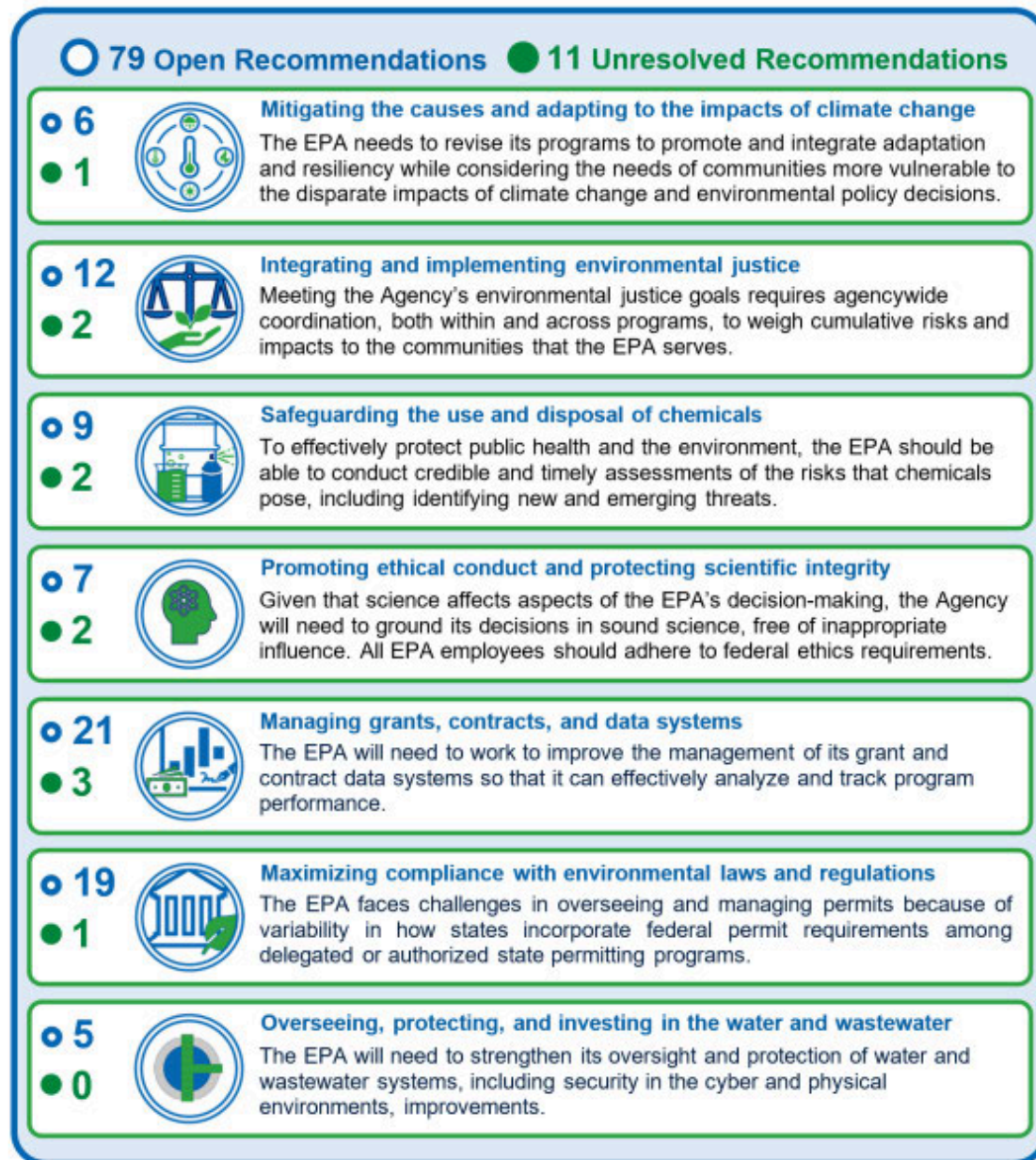

Hello Ms. Cormack,

Please read the following very carefully and thoroughly.

First and foremost maybe it will be best if you check with the FWC special master Deborah Greenspan as to certain discrimination allegations made by [REDACTED] and I against the City of Flint and State of Michigan to make sure that there is NO "overlap" with confidential witness lists and such as to Judge Levy's pretrial order as to BW 3 upcoming trial.

Note: [REDACTED] and I believe that MDCR literally ate donuts and drank coffee while they wrote a report when they instead could have stopped the Flint Water Crisis by sounding the warning whistle. This is to say that a report is not going to replace the plumbing in [REDACTED] house. MDCR was in a perfect position to sound the warning whistle and stop the Flint Water Crisis. Instead, however, they simply talked and counted emails. So, [REDACTED] and I prefer that neither MDCR nor the counting of emails be brought up again.

And for that matter Genesee County and Genesee County Land Bank, Genesee County Sheriffs Department and the City of Flint Police department, and multiple State of Michigan agencies and departments and for that matter the City of Flint Fire Department and City of Flint Blight Elimination Department ALL could have and should have spoken up to STOP the Flint Flint Crisis, but FAILED to do so - because it was much more comfortable not to alert the public of the know dangers of the corrosiveness of the Flint River.

FYI - [REDACTED] and I hope that HELPS the US EPA with its assignment of other parties at fault pertaining to the FTCA EPA claims of \$ 4 billion dollars !!!!!!!!!!!

The purpose of this email is to put my previous email into context with respect to the racism and discrimination that I am experiencing as a minority White (Jewish) person. When I stated that certain residents of Flint allow their vicious pit bulls to attack, this is because of racism and discrimination against me (a minority White Jewish person); when I stated that the Mayor of Flint [Sheldon Neeley] allows this sort of thing to happen, this is because of racism and discrimination against me (a minority White Jewish person).

The Mayor of Flint is Black African-American, the Flint City Council is primarily Black African American, and City of Flint residents are majority Black African American. Although this may be an uncomfortable subject, the truth is that racism and discrimination are perpetrated by a *majority* population - whether that is Black African American, Hisapanic, Asian, etc. - against a *minority* population/person who is in the minority.

One lived example of the way that racism and discrimination is found in the majority population was when [REDACTED] and I lived in California. Where we lived in Northern California had a very low percentage of African Americans living there. So, when a

person (usually White) who belonged to the majority population was racist against [REDACTED] it was very obvious. For example, I witnessed a White man (who belonged to the majority population) call [REDACTED] the "N-word" for no reason whatsoever. Perhaps the White man was envious of [REDACTED] car, the way [REDACTED] was dressed, or even of the fact that [REDACTED] a Black African American man, was with me, a White woman.

Another example, but in the reverse, was when [REDACTED] and I traveled to Michigan from California, [REDACTED] witnessed an incident of discrimination by a Black African-American woman against a Hispanic woman. I did not witness the incident, but [REDACTED] has repeated it to me over the years because he was so shocked by it. ...

[REDACTED] and I were part of a group of people that were traveling to the same destination(s), which had originated in California. This group hadn't eaten for approximately ten hours because the transport service had missed its dinner stop. So when the group finally was able to stop to eat, everyone was hungry. I placed my order and then went to the restroom. [REDACTED] then placed his order, and stepped aside from the line of people. A Hispanic woman behind [REDACTED] tried to place her order with a Black African-American cashier. After the Hispanic woman had tried to place her order (the Hispanic woman spoke very little, if any at all, English), a White woman cook shouted to the Black African-American clerk asking what the Hispanic woman had ordered. The Black African-American clerk shouted back that she didn't know because the Hispanic woman couldn't speak English, and then added that if the Hispanic woman couldn't speak English, then she couldn't get any food, and the White cook and the Black African-American cashier started loudly laughing.

The Hispanic woman was nearly in tears and since the Black African-American cashier refused to serve her, the Hispanic woman likely went another ten hours before she was able to eat anything.

Another example of the way that racism and discrimination is found in the majority population occurred when [REDACTED] and I lived in Detroit (a primarily Black city). ...

I shopped at a local store, where one of the Black African-American cashiers was always extremely rude to me when I had to go through her checkout line. However, this same Black African-American cashier was overly friendly to the Black African-American customers who were in front of me in line. It was a pattern with her. So [REDACTED] "tested" her rudeness by standing in line several customers behind me in line and not only witnessing that the Black African-American cashier was overly friendly to the Black African-American customers who were in front of me in line & then rude to me, but also that the Black African-American cashier was overly friendly to the Black African-American customers who were behind me in line - including [REDACTED]

The above examples of racism and discrimination that I have experienced while living in the state of Michigan (in the cities of Detroit and Flint) are but a few of many. I just felt

that as a White Jewish person, it was important for me to relay at least a few of them to you as a means of creating a context for the racism and discrimination that I have experienced.

Again, I will be on the lookout for your EPA Title VI questions. (b)(6) Privacy, (b)(7)(C) Enf. Privacy and I may provide separate answers to each question, so we will do our best to differentiate our answers within the reply to each question. Also, the sooner the questions are sent, the sooner (b)(6) Privacy, (b)(7)(C) Enf. Privacy and I can answer them and return them. Please send the questions to (b)(6) Privacy, (b)(7)(C) E and me.

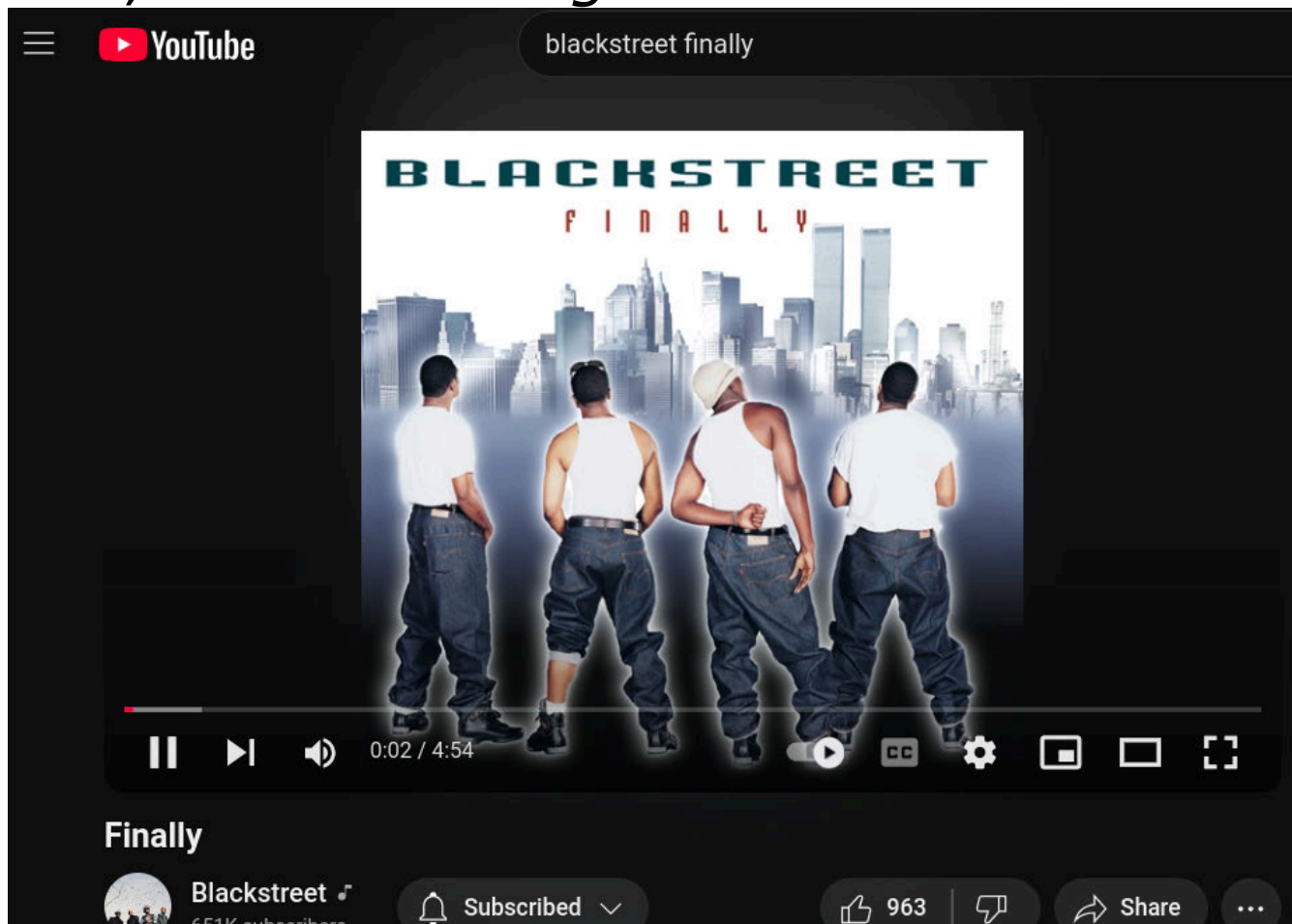
But the difference here with me is -- I HAVE TAKEN THE TIME TO SEEK ONGOING AND GOOD QUALITY HEALTH CARE.... and
