2. **WQP Status Report (15 mins)** (Candice and Lee)

- a. WQP recently completed a database upgrade, updating our instance of PostgreSQL, which will improve performance. We've also been implementing cloud-cost optimizations. In the current sprint, we received a request to remove legacy data in OWSTORET. The Legacy STORET data is a snapshot that we add to the WQP. This current request is causing us to make changes that will allow us to better manage that table. Also picking up development of past bugs and WQP 3.0 Profile in Beta. Currently, the new 3.0 profiles are fully implemented on the USGS NWIS services and should be coming to Beta Portal soon.
