## **Description/responsibilities**

The Office of Inspector General is an independent office within the EPA. The Inspector General Act of 1978 established independent and objective units to be led by an inspector general within each federal agency, in part, to prevent and detect waste, fraud, and abuse related to the programs and operations of the Agency and to promote economy, efficiency, and effectiveness in the administration of those programs and operations. To this end, the EPA OIG performs audits, evaluations, and investigations related to the programs and operations of the Agency.
