The 60-day review standard was adopted Nationally under the direction of the E-Enterprise Leadership Council, in collaboration with state, tribal, and EPA QA professionals after conducting a Lean-Kaizen event in 2018. The ten Regions continued to improve QA processes through an Enterprise Lean Management System (ELMS) project from 2018 - 2020. 2) The U.S. Environmental Protection Agency's Office of Mission Support, Office of Enterprise Information Programs, Enterprise Quality Management Division (EQMD) revised the EPA Requirements

Christy Sangster-Begay (San Carlos Apache) <u>Tribal Caucus</u>	Mission Support Division - Kerry Drake	The Office of Grants and Debarment (OGD) offers EPA's Grants Management Training for Applicants and Recipients, an online training course designed to introduce EPA grant applicants and recipients to key aspects of the entire grant life cycle, from preparation of an application through grant closeout. Region 9 Grants Branch has partnered up with the Region 9 Financial Specialist from Research Triangle Park Finance Center (RTPFC) to provide past grantee administrative and financial training. The Region 9 Financial Specialist attended the 2023 Tribal Conference and provided an in-depth overview of the ASAP System, drawdowns, and other financial grants guidance. Additionally, the Region 9 Grants Branch is available to discuss future in-person or virtual outreach and training requests. Also, Region 9 has invested in guidance, training, and site visits for grant recipients. In 2020, the Region 9 Grants Branch created the "EPA Region 9 Grants Handbook" to address the needs of grant applicants and recipients by providing information on key topics related to applying for, managing and closing-out an EPA grant in an easy-to-understand format (see attached). The Grants Handbook complements the information provided in the EPA's Grants Management Training for Applicants and Recipients modules and helps establish a solid foundation for understanding EPA's grant requirements. Annually, the Grants Branch assesses the need for updating the Handbook based on any changes in grant regulations, policies, etc. And at this time, the Handbook is currently being updated to incorporate the new regulatory changes to 2 CFR Part 200.
