10. Description of what happened, why I believe it happened, and how I was discriminated against.

My husband and I deferred retirement to relocate to Montana and start a family business. We incorporated in the state of Montana and became an ongoing concern in 1982. The business involved turning vast waste piles of mine slag into a useable and environmental friendly commodity used for sand blasting and/or roofing granules. We diligently complied with all federal, state, county, and local regulations. In addition, we generated tax revenue, created employment opportunities and re-stimulated the local economy after years of depression. Other business started thriving (i.e. Rail and Trucking), the local environment improved, and what was once a waste heap was now a resource. We were the inventors and innovators of the processing as well as owners of the intellectual property rights. We were a successful, ongoing enterprise for 25 years that shipped product throughout the United States and exported to foreign countries. We also supplied the United States Navy exclusively.

I believe there is and was a conspiracy between the agencies listed in section 3 above, Atlantic Richfield Company (aka ARCO), Arco Environmental Remediation, LLC (aka AERL), Anaconda Local Development Corporation (aka ALDC), and the Rarus Railway Company (see Attachment 1 for additional information) to deprive my husband and I (and subsequently our children) of our livelihood and property without due process of the law as outlined in the United States Constitution. Through this conspiracy we were forced into years of litigation defending against frivolous law suits regarding processes, patents, and property ownership which continually threatened the viability of the business.

In addition, there is a clear pattern of discriminatory misconduct involving both my sex and age. This misconduct intensified when my husband died and I became a widow. Our God given rights to equal protection under the law was denied by the conduct of all the conspirators.

11. Actions taken and retaliation against:

I acted to protect the family business. The above named governmental agencies, ARCO, AERL, Rarus Railway Co. and the ALDC retaliated through coercion and intimidation. The ALDC, EPA, and AERL coerced to manipulate CERCLA law (USC 42 9601) against my business. They used their knowledge of my husband's death, (b)(6) Privacy, (b)(7)(C) Enf. Privacy my age and my sex to intensify their efforts and put me out of business.
