Re: Closure of Administrative Complaint

Dear (b)(6) Privacy, (b)(7)(C) Enf. Privacy

The purpose of this letter is to notify you that the U.S. Environmental Protection Agency (EPA) Office of Civil Rights (OCR) is closing the administrative complaint filed with the U.S. Department of Justice (DOJ) on December 3, 2010, against the Alabama Department of Environmental Management (ADEM), Lowndes County, AL (Lowndes), and Perry County, AL (Perry). This complaint was subsequently referred by the DOJ to EPA, by letter dated May 3, 2011. Your complaint alleges that ADEM, Lowndes, and Perry violated Title VI of the Civil Rights Act of 1964, as amended (Title VI), 42 U.S.C. 2000d *et seq.*, and EPA's nondiscrimination regulations implementing Title VI, found at 40 C.F.R. Part 7.

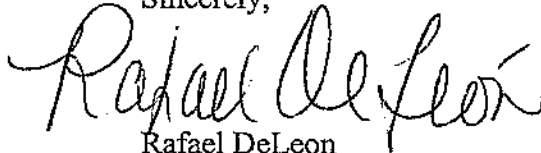
On September 19, 2011, Mr. Anthony Napoli spoke to you by telephone regarding your administrative complaint. During the telephone call, you indicated to Mr. Napoli that you wanted to withdraw the complaint. Therefore, OCR is closing this administrative complaint effective the date of this letter and will not take any further action. You may file a new complaint in the future, but please note that complaints must be filed within 180 days of the alleged discriminatory act(s) as described in our previous correspondence to you.
