My office received a letter from a gentleman named (b)(6) Privacy, (b)(7)(C) Enf. Privacy from Guanica, Puerto Rico. He alleges that the Puerto Rico Aqueduct and Sewer Authority and Costa Mar Construction used discriminatory practices regarding EPA funds.

My office is looking into the civil rights claims but I wanted to forward (b)(6) Privacy, (b)(7)(C) Enf. Privacy concerns to OIG as well.
