- Dear Civil Rights —... I'm writing to see if there are any organization to help poor people of color protect there civil rights from the courts.
- Poor people of color are given ineffective assistance of counsel to help them protect there rights in a criminal case, the courts call it a "reasonable" amount of representation.
- The court appointed that I was given, did not even learn about what happen the night in question, from my point of view until seven days before the bench

trial he coerced me into was to start. But he held a readiness conference, and a preliminary hearing on my behalf.

- The first time I met the public defender was at the readiness conference, he introduced himself, then told me there offering you eight years, then said, he thought that was too much, were gonna take this to trial. This was all he said, then turned and walked away, the next time I seen the public defender was at the preliminary hearing. There was no evidence presented nor any defense on my behalf, because he never took the time to ask me myside of what happen the night in question. I felt like a fish out of water at the preliminary hearing.
- Now at our next meeting is where the public defender coerced me into a bench trial, after telling me we were going to trial. He could not, and did not, investigate or prepare for my case, because he had another trial he was preparing for at the same time that he had my case. So he coerced me into a bench trial without any investigation, there was no evidence presented, nor any witnesses called on my behalf.



I was taken into a closed courtroom where this 'illegal conviction took place, before the trial started, the judge told the deputy district attorney "too not be dragging her feet on this one".

- The prosecutor made misstatement after misstatement, presented false evidence with no objection from the public defender, and gave an unfair summerization of my bench in her closing arguments
- The judge overlooked the overwhelming evidence in support of my self-defense claim in the testimony of the victim. He over looked the CAL JIC 5.30-5.50, and 5.51. I wrote this judge over 11 letters about not being represented, and pointed out some overwhelming evidence in my favor. It was during my appeal that I notice that the evidence I spoke of in some of my letters had been deleted from the transcript. The appellate attorney I was given would not raise any of my issues nor investigate the alteration and deletions I complained about. In fact she was applying for a job with the public defender's office at the same time she was handling my appeal. She try'd to get me to drop my appeal. I was illegally convicted and being held aagainst my will, this is an ongoing violation of poor people

of color, civil rights. So therefore I wanted to see if you knew of any organizations that help poor people of color fight for there rights, after being illegally convicted by an unjust justice system.

- (b) (6) Privacy, (b) (7)(C) Enforcement Privacy was in the Military and a member of the Los Angel Police Dept, and you see how he was done. He made allegations that were being made 20 years before he was even born. Who's standing up for are rights, because the federal government prohibits any organization that recieves federal funding from assisting people who are incarcerated. Poor People of Color are being denied there rights in the courts because they can't afford to hire someone to protect there rights, the federal government prohibits organizations from assisting people who are incarcerated, and poor people of color have limited education. An enormous amount of minorities are in education to try and get a G.E.D., and people with limited education don't even know how to file an appeal exceptable to the courts, or became Frustrated an just choose to due the time.
- The 13th Amendment section 1. states neither slavery nor involuntary servitude, except as a punishment for



crime whereof the party shall have been duly convicted, shall exist within the United States, or any place subject to their jurisdiction.

- The 14th Amendment section 1. states all persons born or naturalized in the United States, and subject thereof, are citizens of the United States and of the state wherein they reside. No state shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any state deprive any person of life, liberty, or property without due process of law; nor deny to any person within its jurisdiction the equal protection of the law.
- These right are being violated at a high rate of speed, there are studies that project the anormous amount of discrimination and violation of poor people of color rights. In California there's a study that shows Private Prison are 89% people of color, the Public Prison's are 75% filled with people of color. There's overwhelming evidence that a "LARGE" amount of poor people of color are being discriminated against, and there rights are being violated by the courts. Overcrowding

made people look at the prison system, even the Attorney General Eric Holder stated, that there are far too many people in prison for long periods of time, for no good reason!

- I seen the way the courts orchestrate these illegal convictions First hand, the judge the prosecutor, the court stenographer, as well as the public defender all played there part in violating my rights in this fraudulent act. Thank you for your time and concerns
