Foul Oyster Shells

- One day in 1999 Ameripure Oyster Company just landed our (b) (6) Privacy. Not even 20 feet from our front door. No one told us nothing, we never signed or agreed to anything, No one asked nothing, at that time about 5 families lived our (b) (6) Privacy.
- Now its one family, my husband and I. The neighborhood is black, The front of their building faces The railroad Track, The back part of it is only a few steps from our front door.
- Its been 15 years they have been here. The first 5 years I was in and out of hospitals with my heart valve + lung disease, my husband (b) (6) Privacy had to take care his very sick mother and me, he is disabled too.
- My husband and I, our Neighbors, we talked to them, we talked to the mayor, City Councilman, The police Department about all the unwashed oyster shells being spread out our their parking lot. The buzzards would feed our These shells. The stink and the flies was + still is Horrible.

- Our house is like a bowl on the street, Very low, The street floods, when we get a hard rain, or flood water mixes with the shells and juices + meat, the water contaminates the yard, leaving foul odor and huge earthworms all over our yards. The flies too.
- Now they are putting them in a small section and in this large Bin that drains on the ground. At one time it would drain in the street, The green slime would run down the street, The sun come out and The maggots and flies take over this slime, The smell was awful then and it still is. It gets in The ~~car~~ house, car, flies and all.
- One time the steam from the building would kill the leaves on the 2 big trees in front the house. In may and June (Summer Time) The leaves would turn brown, die and fall. After about 7 years they fixed that.
- Around 2009, They put a refrigerator, The outside of The refrigerator has a Big

fan. It dims the street lights, It used to drain this water that smells like sewage right in front our door. I would go over there to talk to them about it, I'll ask them to wash the street down, They did, sometime. The city Councilman got them to fix that.

- Now This fan blows extremely hot air all day from the loud refrigerator, It stinks too. The heat from This fan is so hot, you can stand in the front yard in the winter with no coat or sweater on. Now the front of the house is all messed up from This heat, it look like grease spots all over it. Now as of June 28, 2014, They have blocked off the Top part of the fan where the heat comes from.

- But the bottom part of the fan itself is very loud, you can't hear outside, you can't hear a knock at the door, That's dangerous, getting in and out the car at night, you can't hear Nothing. My husband (b) (6) Privacy is very depressed, we both are disabled too. We both have Chronic Stomach problems, I know its because of this stink. we can't

- sit outside, we can't barbecue or have company over because of this stink, flies, gnats and the noise. The flies always get in the house.
- Their 18 Wheeler Trucks passes all day and Night, loading and unloading, making this loud Thumping Noise, that sounds sometimes like a bomb, wakes you up early mornings & Night. They park all over The place, Driving fast, Killed a few of our pets, my grandkids Can't play outside because of The traffic from The Trucks and Stink, open The doors The flies get in.
- 13 years ago They put This Big Butene Tank just a few steps from our house, I'm so afraid of This Tank. Mrs. Laverda Died in 2004, afraid of This Butene Tank.
- When They cut grass, They cut up paper & trash too, grass and trash goes in the street, They leave it there. A hard rain comes the street floods because the drain get all stopped up. (b) (6) Privacy had to remove all that trash and grass

from the drain so the water can drain off the street. We have talked to them about this too, they still do it.

- It's plain to see that this is environmental racism, it's very ugly. The mayor, Raymond Harris told us we should get a lawyer, he blames Sam Jones, Raymond Harris signed a lease for this company another 10 years and said, they are not going nowhere. They have also brought 3 lots over (b) (6) Privacy (b) (6) Privacy

- We talked to a few lawyers, they never call back, no one wants to talk to us. This is a nuisance, we just want a normal, comfortable life, this is so unfair, we are not niggers looking for money. Please help us or direct us to someone who can. We are miserable, they have broken many laws here, not us. (b) (6) Privacy
