

I lived and played in the contaminated area as a child years ago and perhaps my previous health problems with rare cancer and cysts may have been caused due to exposure from the site. I am deeply troubled and concerned about the currently living in (b)(6) Privacy, (b)(7)(C) Ent. Privacy adjacent to the toxic graveyard. We must address the deadly impact of environmental racism and the urgent need to

eliminate environmental hazards in low-income and minority communities in the U.S. a top priority.

It appears officials at every level in government have acted with deliberate indifference and a total disregard for public safety, civil rights, the health and welfare of the ethnic citizens affected in the vicinity of the toxic zone in denying them meaningful notification of the present dangers.

The City of Norfolk, Norfolk Southern, DEQ, EPA and Virginia Power's refusal to take corrective actions to prevent further exposure and their failed enforcement of environmental laws, are simply unreasonable and unacceptable to the citizens of Norfolk.



The group has filed an EPA report violation and informed the White House about the environmental practices and dangers of the City's behavior as very suspect, the intentional downplay of this pollution; couple with the established fact Norfolk Southern, Virginia Power and Norfolk officials have never complied with the EPA or DEQ, and refused to secure permits to properly cap the site and resolve contaminated soil and ground-water migration off-site as required by law must finally be investigated.

The families living, working and children playing in these communities have a fundamental right to know they are living in housing of which the soil is contaminated and it's cruel punishment to deprive the men, women, and children of this community that basic right.
