This is to notify you that the U.S. Environmental Protection Agency (EPA) Office of Civil Rights (OCR) received your complaint on June 24, 2015, alleging that the West Virginia Department of Environmental Protection Office of Abandoned Mine Lands and Reclamation, Kinzer Drilling, LLC, and Energy Corporation of America violated Title VI of the Civil Rights Act of 1964, as amended (Title VI), 42 United States Code (U.S.C.) §§ 2000d *et seq.*, and the EPA's nondiscrimination regulations found at 40 Code of Federal Regulations (C.F.R.) Part 7.

The OCR is responsible for processing and investigating complaints alleging discrimination by programs or activities that receive financial assistance from the EPA. Pursuant to the EPA's nondiscrimination regulations, the OCR will review the complaint for acceptance, rejection, or referral to another Federal agency. *See* 40 C.F.R. § 7.120(d)(1). Once this jurisdictional review is completed, the OCR will notify you about its decision.

I received your second letter this week regarding your property in Mingo County, West Virginia and as a result, I have further investigated your claims. What I have found reaffirms that your complaints are not with Energy Corporation of America (ECA).


- First off, I want you to understand that we have never used Kinzer Drilling as a contractor in our business. Therefore, if any damage resulted from their operations, it was not for business conducted for ECA.
- Secondly, we have not drilled or blasted in Mingo County in decades.
- Thirdly, as you can see from the enclosed map, our closest wells (noted with a blue asterisk*) are several miles from your property. And again, we have not drilled at any of these sites since the 1980s.

It is also important to note: according to Page 1 of the *West Virginia Bureau of Environmental Protection Blasting Complaint Investigation* report you provided, "**(b) (6) Privacy** felt she had damage due to blasting from the above permit, which has not blasted since 5/30/12. After explaining this to her she now feels her damage is due to underground mining from another company. She has water damage and mold damage to her home which I explained is not caused by blasting. She feels now she has subsidence from Wolfcreek Mining, which may have caused her house to settle and roof to leak." Please note: the above permit referenced was for Consol of Kentucky, Inc. – Southern West Virginia Resources, not ECA. And to reiterate, ECA did not drill or build any natural gas wells in Mingo County during the time frame listed in the report (over the last two to three years).

As the permit was for a different company, ECA has not drilled wells in your area for several decades, the damage was not caused by natural gas development, and ECA has never used Kinzer Drilling in our business, I am at a loss to understand why you are contacting our company about this matter. Again, I am sorry that we cannot be of any assistance in this matter since it is not, in any manner, related to ECA.

I wish you all the best and hope you are able to contact someone who is capable of responding to your complaints.




Structures No's NT-47 & NT-56



Notice is hereby given that Consol of Kentucky, Inc., P.O. Drawer L Oakwood, VA 24631, phone number (276) 498-8261, permit number O-8-85 situated in the Harvey District of Mingo County, approximately 1.3 miles northeast of Naugatuck, WV, will be conducting blasting activities in accordance with all State and Federal Laws and as approved by the Department of Environmental Protection.

Blasting activities will occur Monday through Saturday from "**sunrise to sunset**" No blasting shall be conducted on Sunday. Blasting is to commence on August 11, 2010 and continue through August 11, 2011.

Ten minutes prior to and immediately after each blast, all access to the specific area will be safeguarded from unauthorized entry. The warning signal prior to each blast shall be from an air horn audible to at least one half mile from the blast. The warning will be given three (3) minutes prior to detonation and will consist of three (3) short blasts of five (5) seconds duration with five (5) seconds between each blast. The all-clear signal shall be one (1) long blast from an air horn of twenty (20) seconds duration.

Blasting shall be conducted in such a way so as to prevent adverse impacts to the public or the environment.

Blasting activities will not be conducted at times other than those announced in the blasting schedule except in the event of an emergency situation where rain, lightening, or other atmospheric conditions, or operator or public safety requires unscheduled detonations.

Thank you for contacting the U.S. Environmental Protection Agency (EPA), Office of Civil Rights (OCR). We understand that you have some concerns about damage to your home and property, and that you have had some difficulty identifying who is responsible for that damage. In your complaint letter, you indicated that you had contacted the West Virginia Department of Environmental Protection, Office of Abandoned Mine Lands and Reclamation; Kinzer Drilling, LLC; and Energy Corporation of America regarding your property and their involvement in this matter. We would like to assist you. However, we need more information to correctly determine if the OCR can help you.

The OCR is responsible for processing and investigating complaints that allege discrimination by programs and activities receiving financial assistance from EPA. We enforce several civil rights laws, which, together, prohibit discrimination on the basis of: race, color, or national origin (including on the basis of limited-English proficiency); sex; disability; and age by applicants for and recipients of federal financial assistance from EPA.

Pursuant to the EPA's nondiscrimination administrative regulations, the OCR conducts a preliminary review of administrative complaints for acceptance, rejection, or referral to another agency.
