**Re: Rejection of Administrative Correspondence**

Dear (b)(6) Privacy, (b)(7)(C) Enf. Privacy

This letter is to notify you that the U.S. Environmental Protection Agency (EPA), Office of Civil Rights (OCR), has completed its review of your correspondence received by OCR on April 18, 2015. Your correspondence alleged civil rights violations by EPA due to the RCRA designation and selected corrective measures at the former Koppers Wood Treatment Plant in Carbondale, Illinois. After careful consideration, the OCR has concluded that it cannot accept your complaint for investigation, as the jurisdictional requirements have not been met. Accordingly, your complaint is rejected and this matter is closed as of the date of this letter.

The OCR is responsible for processing and investigating complaints alleging discrimination by programs or activities that receive financial assistance from the EPA. To be accepted for investigation, a complaint must meet jurisdictional requirements described in the EPA's nondiscrimination regulations. First, it must be in writing. Second, it must describe an alleged discriminatory act that, if true, would violate the EPA's nondiscrimination regulations (i.e., an alleged discriminatory act based on race, color, national origin, age, sex, or disability). Third, it must be filed within 180 days of the alleged discriminatory act. Finally, the complaint must be filed against an applicant for, or recipient of, EPA assistance, which has allegedly committed the discriminatory act.

The OCR is rejecting your complaint because the OCR does not have jurisdiction to investigate alleged civil rights violations by EPA, as EPA is not an "applicant for, or recipient of, EPA assistance. OCR is aware that the (b)(6) Privacy, (b)(7)(C) Enf. Privacy have been in touch previously with Alan Walts, Director of the Office of Enforcement and Compliance Assurance, Region 5. Accordingly, OCR is copying Mr. Walts on this letter and referring this matter to him
