PETITION FOR REVIEW

Pursuant to Section 307(b) of the Clean Air Act, 42 U.S.C. § 7607(b), and Federal Rule of Appellate Procedure 15, Petitioner the State of Texas petitions this Court for review of the United States Environmental Protection Agency and former Administrator Michael S. Regan's final action entitled *Finding of Failure To Attain the Primary 2010 One-Hour Sulfur Dioxide Standard; Texas; Rusk and Panola Counties Nonattainment Area*, 89 Fed. Reg. 101,894 (December 17, 2024) ("Final Rule"). Notice of the Final Rule was published in the Federal Register on December 17, 2024, a copy of which is attached to this filing as Attachment 1 in accordance with Fifth Circuit Rule 15.1(b).

Jurisdiction and venue for this petition are proper in this Court under 42 U.S.C. § 7607(b)(1). The Final Rule finds that the Rusk and Panola Counties, Texas nonattainment area failed to attain the 2010 one-hour primary sulfur dioxide national ambient air quality standard by the Clean Air Act applicable attainment date of January 12, 2022. Therefore, the Final Rule is a locally or regionally applicable final action of the EPA Administrator and is not "nationally applicable" or "of nationwide scope or effect." 42 U.S.C. § 7607(b)(1). This petition for review is timely filed within 60 days of the date of publication of the Final Rule in the Federal Register. *Id.*
