Re: Referral of Administrative Complaint of Discrimination

Dear Ms. Quinn and Mr. Farrell:

On May 23, 2019, the U.S. Environmental Protection Agency (EPA) External Civil Rights Compliance Office (ECRCO) received a complaint from an employee of the Federal Railroad Administration. The complainant alleged that he had been discriminated against on the basis of race (Black) by employees of the Law Enforcement Division of the Georgia Department of Natural Resources (GA DNR).

This complaint involves the actions of officers of the GA DNR Law Enforcement Division during the period of heightened security prior to Super Bowl LIII. Super Bowl LIII had been designated a National Special Security Event (NSSE) by the DHS Secretary<sup>1</sup>. By Presidential directive, the U.S. Secret Service, an agency located within DHS, is the lead agency for design and implementation of operational security plans for NSSEs<sup>2</sup>. DHS provides federal financial assistance to GA DNR. In light of this, due to the subject matter of the allegations, ECRCO is referring the complaint to DHS's CRCL for appropriate handling.

Similarly, the Department of Interior (DOI) provides federal funding assistance to the GA DNR and has an Office of Law enforcement with duties similar to those handled by GA DNR's Law Enforcement Division. As such, due to the subject matter of the allegations, ECRCO is referring the complaint to DOI's Public Civil Rights Division for appropriate handling.

Considering these circumstances, ECRCO is closing this complaint as of the date of this letter. A copy of the complaint as well as a copy of our letter to the Complainant is enclosed.
