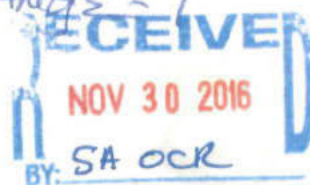

I AM WRITING TO YOU IN THE HOPE THAT
YOUR OFFICE MAY BE ABLE TO HELP IN THIS
MATTER.

ALL OF THE "BOX-CAR" LIKE CELLS HERE HAVE
A SHOWER IN THE ROOMS. ALSO, THEY ALL
HAVE A DRAINAGE/SEWERED WHICH IS
CAUSING MEDICAL PROBLEMS I JUST BECAME
AWARE OF THANKS TO A PBS SHOW.

THERE IS MOLD IN BOTH THE DRAINAGE &
THE VENT BLOWING OUT AIR OVER THE
DRAIN. THE DRAINAGE HAS "BLACK MOLD" THAT
BECOMES AIR BORN WHEN IT DRIES OUT. . . AND
THE VENT OBVIOUSLY HAS MOLD BECAUSE ITS
DIRECTLY UNDER THE SHOWER. I HAVE
BEEN SEVERELY INJURED BY THESE "SPORES"

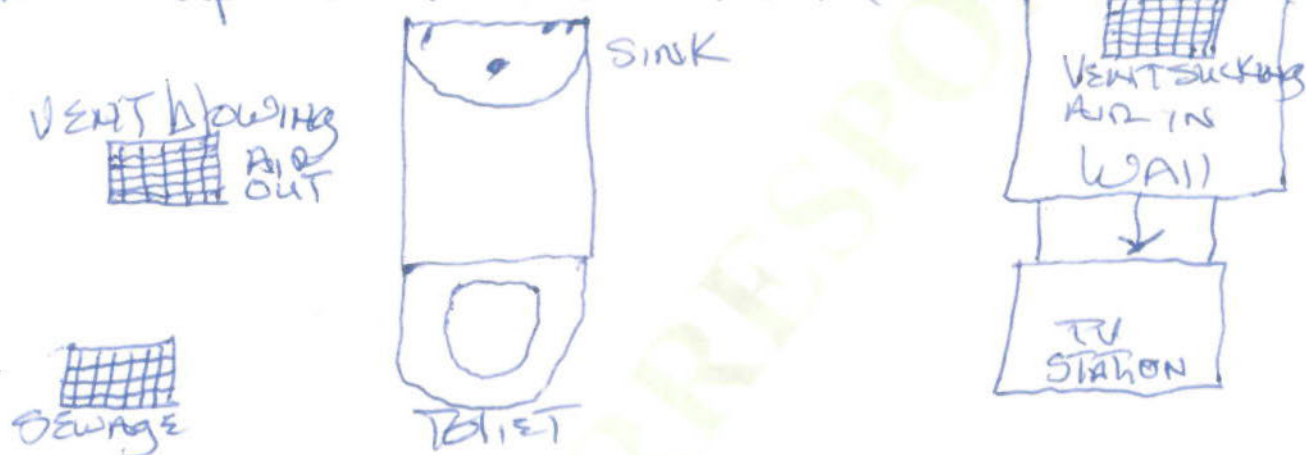
