TO WHOM IT MAY CONCERN:

On or about May 4th, 2024 after an illegal eviction by (b)(6) Privacy, (b)(7)(C) Enf. Privacy from (b)(6) Privacy, (b)(7)(C) Enf. Privacy Buffalo, NY 14212, we were forced to come back to live in our dilapidated Church located at (b)(6) Privacy, (b)(7)(C) Enf. Privacy Syracuse, NY 13202. As (b)(6) Privacy, (b)(7)(C) Enf. Privacy Church Plan Administrators we inherited (b)(6) Privacy, (b)(7)(C) Enf. Privacy Church from the late (b)(6) Privacy, (b)(7)(C) Enf. Privacy who left us the property. We live upstairs. The property is designated as religious property. It is mixed usage and we live upstairs. For the last nearly 4 years we have been renovating our inherited property using our own funds. In December 2020, we became the legal lienholders and have been such ever since (see enclosed attachment). We have also received Emergency Heap Grants also for the same location from the Onondaga County Dept of Social Services for (b)(6) Privacy, (b)(7)(C) Enf. Privacy When we arrived on or about May 4th, 2024 we went to Onondaga County Social Service for immediate assistance. We still don't have a working furnace in our church, or working toilet, we use Walmart commode inside. We have been forced to live the filth of the earth, but we will still serve our God. this but we trust etc. We were immediately denied our request for an Emergency Grant from Onondaga County Social Services who directed us to NYSERDA. We did contact NYSERDA who came and began insulating our property who gave us new circuit breaker and sub panels by the grace of God. NYSERDA also installed a heat pump that runs off of electricity. When we inherited (b)(6) Privacy, (b)(7)(C) Enf. Privacy Church in December 2020 we have never had hot water. The old furnace system was removed because it was faulty and the hot water tank likewise because it was in very bad condition. Since we inherited (b)(6) Privacy, (b)(7)(C) Enf. Privacy Church we have put a lot of money into trying to renovate it without the necessary funding. When NYSERDA installed our heat pump in the basement they attached it to the water line in the basement. This was for the purpose of us finally getting hot water running off of electricity. After NYSERDA completed their last project on or about late August 2024 we were informed that the project would be closed out and the next one submitted for approval. We were told by (b)(6) Privacy, (b)(7)(C) Enf. Privacy Energy Services Manager, of (b)(6) Privacy, (b)(7)(C) Enf. Privacy Inc. (Heating and Cooling) that the next project that would be submitted was for our heating to be installed before winter. On or about October 15th, 2024 we hired a private contractor (b)(6) Privacy, (b)(7)(C) Enf. Privacy of JC Home Improvement, (b)(6) Privacy, (b)(7)(C) Enf. Privacy Syracuse, New York 13206, (b)(6) Privacy, (b)(7)(C) Enf. Privacy to install the hot water lines from the heat pump to our apartment on the second floor. After JC Home Improvement installed the new water lines the main line into our building busted the same night. We immediately reported our findings to General Contractor (b)(6) Privacy, (b)(7)(C) Enf. Privacy of JC Home Improvement that our basement was flooded. He came by the next morning on October 16th, 2024. When he arrived he could not repair what he had done. So he called the City of Syracuse Water Department to stop the flooding. The Water Dept responded on October 16th, 2024 and turned off our water until the piping in the basement was repaired. So now we have no running cold or hot water, no heating, no working bathroom sink or toilet, and it is getting extremely cold upstairs. Also we are disabled and Sarah Iris Israel takes medication and needs water to take medication. Our piping in the basement needs to be repaired immediately. We need water and the Bible says:

“ When the poor and needy seek water, there is none, and their tongue faileth for thirst, I the LORD will hear them, I the God of Israel will not forsake them “

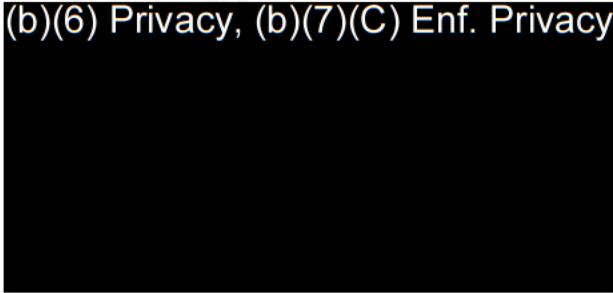

Also, we received a letter from NYSERDA on October 16th, 2024 that informed us that we need a HEAP award letter so they can continue to install the heater that will run off of the heat pump. Now we don't have running water so that project for heat cannot be completed until the water line is fixed and water restored. Thank you!
