SUBJECT: Fiscal Year 2025 Allotments for the State Revolving Fund Provisions of the Infrastructure

Investment and Jobs Act and Base Program Funding

This memorandum provides final allotment tables for the fiscal year 2025 Infrastructure Investment and Jobs Act State Revolving Fund General Supplemental and Emerging Contaminants capitalization grants, as well as Base program funds appropriated under the Full Year Continuing Appropriations and Extensions Act, 2025 (PL 119-4) for the Clean Water State Revolving Fund and Drinking Water State Revolving Fund Programs. Terms and conditions will be available to regions on the EPA SRF SharePoint site.

This memorandum does not include allotment tables for the FY 2025 IIJA Lead Service Line Replacement capitalization grants. The U.S. Environmental Protection Agency will announce those allotments when they are finalized in the coming weeks.

I. GENERAL UPDATES

Although total base appropriations for the SRF programs did not change between FY 2024 and FY 2025, the amount of base funding available to states increased because the Full Year Continuing Appropriations and Extensions Act did not include funding for the Community Grants program.

The EPA's Regions should ensure the state SRF managers are aware that, per the IIJA statute, state match for the FY 2025 IIJA General Supplemental Capitalization Grants remains at 20 percent.

II. ADDITIONAL SUBSIDY PROVISIONS

There are no changes in the additional subsidy authorities from FY 2024 to FY 2025. For the base program funding provided through the Full Year Continuing Appropriations and Extensions Act, 2025, there are still two different additional subsidy authorities for each SRF. The diagrams below visually represent the mandatory additional subsidy authorities under the Base and IIJA General Supplemental capitalization grants. The IIJA Emerging Contaminant funding is 100 percent additional subsidy, so a diagram is not provided below. The DWSRF diagrams also include the optional set-aside funding amounts that states can take to administer a variety of state drinking water programs, as well as provide assistance to water systems. These funds do not revolve and therefore states should be strategic in the amount of set-aside funding they take in conjunction with the additional subsidy.

Diagram 2: Example \$100 CWSRF FY 2025 Full Year Continuing Appropriations and Extensions Act




Diagram 3: Example \$100 DWSRF FY 2025 IIJA General Supplemental Capitalization Grant





Diagram 4: Example \$100 CWSRF FY 2025 IIJA General Supplemental Capitalization Grant
