Region 1

Capitol Region Council of Governments, CT

RLF Supplemental Grant
\$750,000

In addition to the \$2,450,000 in EPA funds already awarded, the Capitol Region Council of Governments Brownfield Revolving Loan Fund (RLF) has been selected to receive \$750,000 through the Bipartisan Infrastructure Law (BIL) because it has a high-performing RLF program with significantly depleted funds. The RLF program has successfully made loans or subgrants leading to three cleanup projects that are either completed or in progress. Projects highlighted for use of the BIL funding include a Data Center in Hartford and the Collinsville Axe Factory in Canton.
