The Department is in receipt of a May 21<sup>st</sup> electronic mail message confirming the termination of the above referenced permit/license for hydrostatic discharges from a fuel oil terminal and transfer facility that expired on March 20, 2025. It is our understanding there have not been any hydrostatic discharges for the past three years and there are no currently planned discharges from the permitted facility located at 17 Main Street in South Portland. We will be terminating the permit/license in our database so that Discharge Monitoring Reports (DMRs) and billing statements are not sent to you in the future.

By copy of this letter, we are notifying the U. S. Environmental Protection Agency that the MEPDES permit is being terminated.

If hydrostatic testing should be conducted again, please be advised that a permit and or license will be required from this Department prior to and for any future discharge of pollutants from this facility to the surface waters or ground waters of the State of Maine, whether under current ownership or new ownership. Any new permit or license would be based on the characteristics of the effluent being discharged and the impacts of the discharge on the quality of the receiving water.
