Subject: GSP Merrimack LLC (formerly PSNH Merrimack Station, dba Eversource) Certification of NPDES Permit No. NH0001465

Dear Ms. Weitzler:

By letter dated September 28, 2011, the U.S. Environmental Protection Agency (EPA) requested State Certification of NPDES Permit NH0001465 for Merrimack Station in Bow, NH.

The EPA publicly noticed the availability of the draft permit, including the Fact Sheet, in a notice dated April 18, 2014. EPA also publicly noticed a Statement of Substantial New Questions for Public Comment (the Statement) in a notice dated November 28, 2017. The end of all of the extended public comment periods for the Draft Permit, Fact Sheet and the Statement was December 18, 2017. The Public Notices stated that the Draft Permit, Fact Sheet, Statement as well as the Administrative Record could be obtained at the EPA New England website at https://www.epa.gov/npdes-permits/merrimack-station-draft-npdes-permit.

After appropriate staff review of the Draft Permit, Fact Sheet, Statement, public comments, and EPA's response to comments, State Certification is hereby granted pursuant to Section 401 of the Clean Water Act. The permit will ensure that the requirements of Title 50 RSA 485-A, and administrative rule Env-Wq 1700 (Surface Water Quality Regulations) are met.

Upon final issuance by the federal EPA, the Department of Environmental Services may adopt the permit, including all terms and conditions as a state permit pursuant to RSA 485-A:13.
