



- Engagement toolsinclude: social media, in person events, surveys, and newsletters








Soboba's Climate Change Vulnerability Analysis





California Department of ______ Transportation Grants

- This grant allows Soboba to update the 2018 Climate Change Vulnerability Analysis.
- An Adaptation Plan report will be created based off of the updated vulnerabilities.






Climate Adaptation Program at SoCalGas

California Grant Funding

Regional Resilience Planning and Implementation Grant Program (RRGP) under the Integrated Climate Regional Adaptation and Resiliency Program.






Eligible to California Tribal Government, Public Agencies, and Nonprofits.

This grant program funds projects led by partnerships that involve multiple jurisdictions working together to address the most significant climate change risks in their region, especially in communities that are most vulnerable to climate change impacts.






RRGP Funding Details

Regional Resilience Planning and Implementation Grant Program (RRGP) is granted by the Governor's Office of Land Use and Climate Innovation.




Estimated amount awarded is \$150,000 - \$3,000,000. Planning grants can be awarded up to \$650,000.



Applications typically close in August with 10 to 20 grants being awarded in late December.







Soboba's Environmental Adaptation Work Currently

- Soboba was awarded the Regional Resilience Planning and Implementation Grant under the Integrated Climate Regional Adaptation and Resiliency Program.
- Soboba partnered with the Santa Ana Watershed Project Authority on this grant to develop a Santa Ana River Watershed Climate Adaptation Resilience Plan.
- This plan will address climate risks like drought, wildfire, and flooding.
- Soboba's goal is to ensure Tribes have a voice in the can be met in the future.


Environmental Change Survey




