In accordance with the Rhode Island Pollutant Discharge Elimination System (RIPDES) Regulations promulgated under Chapter 46-12 of the Rhode Island General Laws of 1956, as amended, the Rhode Island Department of Environmental Management (DEM) hereby acknowledges termination of the above-referenced RIPDES Permit.

The permit, which was issued on September 13, 2010, and expired on November 1, 2015, pertained to stormwater discharges associated with industrial activity from the former Getty Terminals Corporation site located at Dexter Road and Massasoit Avenue in East Providence, RI. Such discharges of stormwater from the former fuel terminal were directed to a stormwater collection system which ultimately discharged to the Ten Mile River.

Correspondence dated February 16, 2016 submitted by Metro Environmental Services, LLC. on behalf of Getty Realty to DEM indicated that discharges from the site were eliminated in April of 2015. In addition, an application for renewal of the RIPDES Permit was never submitted to DEM in accordance with RIPDES Rule 10, and the previous permit has expired. Therefore, in accordance with RIPDES Rule 8, as of April 2015, the above-referenced RIPDES Permit was no longer required for your facility and the terms and conditions contained therein were no longer in force.
