EPA Programs and Activities Selected by State Single Points of Contact for Intergovernmental Review under State SPOC Procedures pursuant to <u>40 CFR Part 29</u>.

**California**: The State of California selects all eligible federal assistance programs for review. In addition, all State agencies are required to submit their notice for any federal assistance pursuant to the State Administrative Manual (SAM) Section 0912 to the State Clearing House (SCH). Furthermore, in accordance with Assembly Bill (AB) 1348 (Irwin, State Clearinghouse), the SCH is responsible for reporting on all federal assistance applied for and received in California, regardless of whether programs and activities are subject to Intergovernmental Review under Executive Order (EO) 12372.

Please be aware that the California SCH **only** accepts applications for Federal financial assistance online.

To facilitate this reporting process, the California SCH advises applicants for EPA funding for projects that will be carried out in California to follow these steps:

- 1. Visit the online submission portal: <a href="https://cfda.opr.ca.gov">https://cfda.opr.ca.gov</a>
- 2. Enter your Assistance Listing number (formerly known as Catalog of Federal Domestic Assistance number) listed in the 3rd category.
- 3. Complete all required fields as prompted.
