SUBJECT: Reallotment of Fiscal Year 2023 & 2024 Infrastructure Investment and Jobs Act Lead Service Line Replacement Drinking Water State Revolving Funds

This memorandum announces the availability of reallotted FY 2023 and FY 2024 Infrastructure Investment and Jobs Act (P.L. 117-58) Drinking Water State Revolving Fund Lead Service Line Replacement dollars. This action makes additional drinking water infrastructure funds for lead service line replacement available to states across the nation with higher need. **Eligible states, Puerto Rico, and Washington, D.C. have until September 30, 2026, to apply for and receive their portion(s) of the reallotted funds.** Any available funds remaining unawarded after that date will be available for reallotment.

By law, the U.S. Environmental Protection Agency must reallot any unobligated funds after the second fiscal year of availability. All DWSRF programs (the 50 states and Puerto Rico) that received their full DWSRF allotment within the two years of availability are eligible for reallotted funds, as well as Washington, D.C. The process is explained in the September 11, 2020, memorandum, [State Revolving Fund Capitalization Grant Reallotment Procedure](#).

For FY 2023 reallotments, there are \$545,961,000 of FY 2023 LSLR funds now available to 41 states, Puerto Rico, and the District of Columbia.

- The states of Alaska, Arizona, Maine, Montana, New Mexico, Oregon, South Dakota, Washington, and Wyoming declined a total of \$231,532,000 of their FY 2023 IJIA LSLR allotments, which makes them ineligible for reallotment in accordance with the Safe Drinking Water Act Section 1452 (a)(1)(E).
- In addition, the EPA de-obligated \$226,138,000 from Florida's FY 2023 IJIA LSLR allotment and \$88,291,000 from Texas' FY 2023 IJIA LSLR allotment.

For FY 2024 reallocations, there are \$586,070,000 of FY 2024 LSLR funds now available to 36 states, Puerto Rico, and the District of Columbia.

- The states of Alaska, Arizona, Arkansas, California, Idaho, Maine, Montana, Nevada, Oregon, South Carolina, South Dakota, Utah, Vermont, and Washington declined a total of \$420,405,000 of their FY 2024 IIJA LSLR allotments, which makes them ineligible for reallocation in accordance with the Safe Drinking Water Act Section 1452 (a)(1)(E).
- In addition, the EPA reduced Florida's FY 2024 IIJA LSLR allotment and increased Texas' FY 2024 IIJA LSLR allotment adding an additional net total of \$165,665,000 to be reallocated.

Attachment A lists the state-by-state FY 2023 IIJA LSLR reallocation amounts. These reallocated funds carry all program requirements and authorities associated with the FY 2023 IIJA LSLR appropriation, and all current statutory requirements. Attachment B shows the state-by-state mandatory additional subsidy amounts for the appropriation.

Attachment C lists the state-by-state FY 2024 IIJA LSLR reallocation amounts. These reallocated funds carry all program requirements and authorities associated with the FY 2024 IIJA LSLR appropriation, and all current statutory requirements. Attachment D shows the state-by-state mandatory additional subsidy amounts for the appropriation.

Please see the above-mentioned September 2020 reallocation memorandum for details about mechanisms regions may use to award the funds and expectations for commitments and disbursements.

The EPA will continue to work with states to ensure that IIJA DWSRF LSLR funds are promptly applied toward assistance agreements supporting lead service line replacement projects.
