SUBJECT: THIS IS FORMAL COMPLAINT OF DISCRIMINATION UNDER TITLE VI OF THE CIVIL RIGHTS ACT OF 1964 AGAINST DUBLIN CONSTRUCTION COMPANY, INC. AND EPA (A FEDERAL GOVERNMENT FUNDED ENITY) AND INVESTIGATOR (b) (6) Privacy, (b) (7)(C) Enf. Privacy

FACTS/SUMMARY:

AFTER, COMPLAINANT'S ATTORNEY REFUSED TO CONTACT THE EPA OF SPILLING DIESEL FUEL AS AGREED IN 2019 AND ONGOIN, COMPLAINANT (b) (6) Privacy, (b) (7)(C) Enf. P ON OR ABOUT AUGUST 18, 2025 CONTACTED THE EPA AND FILED CASE (b) (6) Privacy, (b) (7)(C) E CONCERNING THE DIESEL FUEL SPILLS WHERE CONSTANTLY FLOWING DIESEL

FUEL SPILLED ALL OVER THE GROUND FROM DUBLIN CONSTRUCTION COMPANY INC. WHITE ABOVE GROUND AND BELOW GROUND DIESEL FUEL TANKS AND DISTRIBUTION ISLAND. DUBLIN CITY SCHOOL DISTRICT BUS DRIVERS KEPT CALLING AND COMPLAINING TO COMPLAINANT (b) (6) Privacy, (b) (7)(C) Enf. Privacy THAT NO BODY HAD COME OUT AND CHECKED AND TESTED THE BUS YARD GROUNDS AND THEY WERE STILL TRYING TO ENDURE THE STRONG DIESEL FUEL SMELL.

THE SPILL OCCURS ON DUBLIN CONSTRUCTION COMPANY INC.'S LEASED PROPERTY (b) (6) Privacy, (b) (7)(C) Enf. Privacy DUBLIN GEORGIA) TO DUBLIN CITY SCHOOLS IN DUBLIN GEORGIA. THE LEAK HAD BEEN REPORTED SINCE 2014 TO DUBLIN CONSTRUCTION COMPANY BY THE DUBLIN CITY SCHOOLS AND STAFF AND THEY (THE DIESEL LEAKS) CONTINUED ONGOING. DUBLIN CONSTRUCTION DID NOT FIX THE PROBLEM. THEY WOULD ONLY COME OUT AND BRING GRAY GRAVEL/DIRT PACK AND COVER UP ALL THE WETNESS AND POT HOLES ON THE BUS YARD AROUND THE TANKS. THEY COVERED UP THE YARD WITH LEAKING DIESEL UP TO JUST BEFORE THE TIME OF ABOUT AUGUST 18, 2025, WHEN THE EPA INSPECTOR PHYSICALLY VISTED THE PROPERTY. COMPLAINANT (b) (6) Privacy, (b) (7)(C) Enf. Privacy SENT EPA, (b) (6) Privacy, (b) (7)(C) Enf. Privacy DATED AND TIME STAMPED PHOTO'S HE TOOK OF DIESEL FUEL ALL OVER THE GROUND, CONCRETE SLABS AND DISTRIBUTION ISLAND AND EQUIPMENT. COMPLAINANT INFORMED EPA (b) (6) Privacy, (b) (7)(C) Enf. Privacy OF WHOLE DEAD BIRDS WITH THEIR EYES OPEN LYING IN FRONT OF HIS BUS IN THE MORNINGS THAT WERE NOT THERE THE NIGHT BEFORE COMPLAINANT (b) (6) Privacy, (b) (7)(C) Enf. Privacy LEFT THE BUS YARD. THE CAT THAT WOULD APPEAR NEVER ATE THE BIRDS. COMPLAINANT (b) (6) Privacy, (b) (7)(C) Enf. Privacy SENT (b) (6) Privacy, (b) (7)(C) Enf. Privacy MORE THAN 30 PICTURES, AND INFOMED (b) (6) Privacy, (b) (7)(C) Enf. Privacy HE COULD GO GET MORE AVAILABLE THAT WERE CLEARER THAN THE ONES HE RECEIVED BY EMAIL FROM THE COMPLAINANT. (b) (6) Privacy, (b) (7)(C) Enf. Privacy REFUSED TO LOOK AT OTHER PICTURES STATING IT WAS AGAINST THE LAW TO COVER UP DIESEL WITH GRAVEL BUT RIGHT NOW HE WAS NOT GOING TO MAKE THEM CLEAN BUT A SMALL SECTION AND NOT THE OTHER. EPA, (b) (6) Privacy, (b) (7)(C) Enf. Privacy INFOMED ME (b) (6) Privacy, (b) (7)(C) Enf. Privacy HE WAS DROPPING AND CLOSING THE CASE OUT AND NOT GOING TO DO ANYTHING RIGHT NOW.

DUBLIN CONTRUCTION HAD ALREADY COME OUT AND PAINTED OVER THE CORROSION BROWNISH WETNESS ON WHITE ABOVE GROUND TANK WITH GRAY PAINT, THEN AGAIN WITH WHITE PAINT SHOWED UP. COMPLAINANT (b) (6) Privacy, (b) (7)(C) Enf. Privacy

SENT (b) (6) Privacy, (b) (7)(C) Enf. Privacy THE BEFORE AND AFTER PICTURES OF THE BROWN STREAKS ON THE TANK. COMPLAINANT (b) (6) Privacy, (b) (7)(C) Enf. Privacy EXPLAINED TO (b) (6) Privacy, (b) (7)(C) Enf. Privacy THAT THERE WERE NO RENOVATIONS OF THE BUS YARD FOR FIXING UNTIL THE 98 PERCENT BLACK WORK FORCE OF DUBLIN CITY SCHOOL DISTRICT MOVED TO ACADEMY AVENUE ABOUT THE FIRST QUARTER OF 2025. NOW DUBLIN CONSTRUCTION HAS ADDED WHITE CONCRETE PARKING SLABS INSIDE THE GATE ALONG WITH WHAT APPEARS TO BE BLACK SOLAR SECURITY LIGHTS ON POLES AROUND THE PERIMETER.

HOWEVER, AGAIN WHAT'S WORSE, THERE IS A CREEK THAT RUNS NEXT TO THE LEAKING DIESEL FUEL TANKS THAT RUNS ABOUT A BLOCK AND HALF INTO THE OCONNE RIVER WHERE THE DRINKING WATER COMES. THE NEIGHBOR HOOD WHERE THE CREEK AND THE LEAKING DIESEL FUEL IS MOSTLY BLACK RESIDENTS. OTHER HOUSING RESIDENTS HAVE ALREADY COMPLAINED TO THE CITY COUNCIL ABOUT DIESEL FUEL DANGER IN CLOSE TO THIS AREA GETTING INTO THE WATER TABLE. THE TANKS ARE NEXT TO THE RUNNING CREEK AND (b) (6) Privacy, (b) (7)(C) Enf. Privacy WAS MADE TO KNOW THIS AND ABOUT OTHERS AT THE BUS YARD GETTING SICK. BECAUSE OF DUBLIN CONSTRUCTION REFUSING TO FIX THE LEAKING DIESEL AND BLACK EMPLOYEES SUFFERING THE VERY SMALL NUMBER OF WHITE EMPLOYEES HAVE SUFFERED AS WELL.

ALSO, DUBLIN CITY SCHOOLS RECEIVES ENTITLEMENTS AND STATE/FEDERAL GOVERNMENT FUNDS AND PAYS/PAID DUBLIN CONSTRUCTION COMPANY LEASE PAYMENTS MONTHLY OR STRUCTURED PAYMENTS SYSTEMATICALLY.

TO THE EPA OFFICE OF CIVIL RIGHTS (OCR):

THIS LETTER SERVES AS A FORMAL COMPLAINT ALLEGING THAT DUBLIN CONSTRUCTION COMPANY, INC. (OWNER OF LEAKING DIESEL FUEL TANKS) RECEIVING FUNDS FROM DUBLIN CITY SCHOOLS A STATE AND FEDERAL GOVERNEMENT RECEPIENT, AND EPA (b) (6) Privacy, (b) (7)(C) Enf. Privacy A RECIPIENT OF EPA FINANCIAL ASSISTANCE, HAS ENGAGED IN DISCRIMINATION ON THE BASIS OF RACE (BLACK EMPLOYEES) IN VIOLATION OF TITLE 6 OF THE CIVIL RIGHTS ACT OF 1964 AND EPA'S NONDISCRIMINATION REGULATIONS.

DESCRIPTION OF DISCRIMINATORY ACTS:

1. ENVIRONMENTAL HAZARD:

A SIGNIFICANT DIESEL FUEL SPILL OCCURRED ON THE WORK SITE GROUNDS AT THE AFOREMENTIONED LOCATION ((b) (6) Privacy, (b) (7)(C) Enf. Privacy), WHICH RESULTED IN INJURY TO (b) (6) Privacy, (b) (7)(C) Enf. Privacy AND OTHER EMPLOYEES (SUBJECTED TO DANGEROUS WORK CONDITIONS). ON OR ABOUT AUGUST 18, 2025, THE EPA INVESTIGATED THE SPILL, ACKNOWLEDGED THE PRESENCE OF FUEL ON THE GROUND, AND INSTRUCTED THE COMPANY TO CONDUCT A PARTIAL CLEANUP.

2. UNEQUAL PROTECTION/NEGLIGENCE:

THE EPA AND DUBLIN CONSTRUCTION COMPANY, INC. PURPOSEFULLY OVERLOOKED THE FULL EXTENT OF THE SPILL AND ITS IMPACT, FAILING TO ENSURE A COMPLETE AND TIMELY CLEANUP. THE COMPANY (DUBLIN

CONSTRUCTION COMPANY, INC) WAS AWARE OF THE SPILL AND DID NOT CORRECT IT FOR APPPROXIMATELY 11 YEARS.

3. DISCRIMINATION:



I (b)(6) Privacy, (b)(7)(C) Enf. Privacy AND OTHERS BELIEVE THE NEGLIGENCE AND FAILURE TO ENFORCE A FULL CLEANUP CONSTITUTES DISPARATE TREATMENT/IMPACT BASED ON RACE.

REQUESTED ACTION:

I REQUEST THAT THE EPA OCR CONDUCT A FULL INVESTIGATION INTO THESE MATTERS TO DETERMINE IF DUBLIN CONSTRUCTION COMPANY, INC AND EPA (b)(6) Privacy, (b)(7)(C) Enf. Privacy VIOLATED CIVIL RIGHTS LAWS AND TO ENSURE THAT APPROPRIATE CORRECTIVE ACTION IS TAKEN TO REMEDY THE DISCRIMINATION AND ENVIRONMENTAL HAZARD.

I DECLARE UNDER PENALTY OF PERJURY THAT THE FOREGOING IS TRUE AND CORRECT.
