Administrative Consent Order No. 1999-AQ-31 was issued to HOLNAM, INC., on September 2, 1999. This Consent Amendment reflects and adopts changes to Section V (Order) and Exhibit "D" regarding the number and size of storage piles that HOLNAM, INC., may have on-site:

1. Paragraph 4(i) of Section V. ORDER is replaced with the following:

Holnam shall locate and maintain the storage pile bases as designated in Exhibit "D", except as provided below, and shall limit the size of the storage piles to no greater than the acreages designated in Exhibit "D". Exhibit "D" shall by this reference become a part hereof. Holnam may relocate a pile specified in Exhibit "D", or add a new pile not provided for in paragraphs 4(ii) or 4(iii), or change the material type of the pile, only after providing written notice to DNR and submitting the results of computer dispersion modeling showing that no exceedances of the PM-10 NAAQS would result.
2. Exhibit "D" of Administrative Consent Order No. 1999-AQ-31 is replaced with the attached revised Exhibit "D."
3. This Consent Amendment to Administrative Order No. 1999-AQ-31 is entered into knowingly and with the consent of HOLNAM, INC. For this reason, HOLNAM, INC. waives its right to appeal this Consent Amendment to Administrative Order No. 1999-AQ-31.
4. In all other respects, Administrative Consent Order No. 1999-AQ-31 remains in full force and effect.
