Dear Mr. Gray:

This program is on-going for the discharge of storm water from the municipal storm sewer system (MS-4) to waters of the United States.

Compliance with the permit conditions

The Town is in compliance with the permit conditions established by the USRPA. The best management practices (BMP's) identified in the Storm Water Management Plan for the six minimum control measure were implemented and information recorded.

Appropriateness of the Selected BMP's

Each of the selected BMP's remain appropriate for meeting the goals of reducing the discharge of pollutants to the maximum extent practicable while protecting water quality and meet the requirements of the Clean Water Act.

Assessment of Progress Toward Achieving Measurable Goals

Minimum Control Measure 1- Public Education and Outreach of Storm Water Impacts

ML1-001

Information regarding storm water issues are included in our Newsletter.

ML1-002- Collection and Disposal

The Town has a working agreement with surrounding towns for a joint Household Hazardous Waste collection day.

ML1-003-Classroom Education

We have instituted a program for classroom education that is on-going

Minimum Control Measure 2 – Public Participation and Involvement

ML2-001 Storm Drain Stenciling

The Town has identified all storm drains and they have been stenciled

ML2-002 Boy Scout Participation

Minimum Control Measure 3 – Illicit Discharge Detection and Elimination

ML3-001 – Storm Drain Map – This map has been developed

ML3-002 – Illicit Dumping

The Town has an active Code Enforcement Program that includes educating the public against illicit dumping of any materials

Minimum Control Measure 4 – Construction Site Storm Runoff Control

ML4-001 Planning Board Site Plan Review

The Town strictly enforces its site plan requirements

Minimum Control Measure 5 – Post Construction Storm Water Management in new development- redevelopment

ML5-001 We have replaced many feet of sidewalks and storm management was included in the design and construction of these sidewalks.

ML5-002 As before, the Planning Board has adopted regulations for buffer zones, storm water management and conservation easements as a large part of every site plan reviewed

Minimum Control Measure 6 – Pollution Prevention/good housekeeping for Municipal Operations

ML6-001 Vehicle Maintenance The Town is continuing our program of properly maintaining Town vehicles and documenting all spills and clean up efforts

ML6-002 Storm Drain Cleaning – The Town has regularly scheduled cleaning of storm drains with contract storm drain cleaners.

ML6-003 Salt Storage – The Town has salt storage buildings

ML6-004 .Used Oil Recycling Program -- The Town has an active used oil recycling program and encourage residents to participate.

Summary of Results of Any Information that has been collected and analyzed

Our residents are much more aware of Waste Water Management efforts and they are readily accepting and practicing recycling as part of their daily routines.

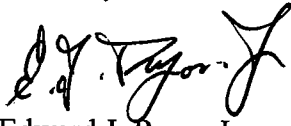
Activities for the next reporting cycle
