Part II. Self-Assessment

The Town of East Bridgewater has successfully implemented or begun implementation of several Measurable Goals noted in East Bridgewater's Notice of Intent. Prior to the development of East Bridgewater's Comprehensive Stormwater Management Program, including Measurable Goals, the Town had an assessment performed of current activities, programs and regulations that could support the NPDES Phase II Stormwater Program. This assessment became the basis for modifying current activities, recommending new programs, and informing Town boards and departments of their obligation toward successful implementation of East Bridgewater's Comprehensive Stormwater Program.

During the initial years of the program, the Town has focused on obtaining the necessary funding to carry out the plan. During 2006, the necessary funding was made available and was approved by Town Meeting. During Permit Year 4, the Town began the development of town-wide stormwater mapping, and outfall inspection and testing in support of an illicit discharge detection program.

During Permit Year 5 (2007) the stormwater outfall mapping and related water quality screening tasks were completed.

East Bridgewater is pleased to present the following summary describing the town's success at implementing the fifth year of the Town's Comprehensive Stormwater Program.

To date, the Town has focused on completing GIS mapping of the drainage system and receiving waters, as approved by the DEP, and water quality screening and testing from the outfall locations that have been mapped.

A more detailed WLA assessment and Land Use Evaluation will follow.

Part IV. Summary of Information Collected and Analyzed

The Town has reviewed the local, state and federal bylaws relative to stormwater and aquifer protection, and appears to be adequately regulated and in conformance with the Massachusetts Stormwater Management Policy. Minor revisions may be required for informing local project proponents of the Phase II one-acre NPDES requirement.

Permit Year 5 Activities and Information

During Permit Year 5, the Town utilized funds from the Massachusetts Water Abatement Trust State Revolving Fund to initiate the activities outlined in the Storm Water Management Plan and began implementing those activities, including the development of full planimetric mapping of the Town. This mapping was used as the basis for the development of town-wide drainage system mapping and the performance of outfall inspections and water quality screening and testing as outlined in the DEP approved scope of work.
