1.0 Self Assessment

The Town of Hadley received a General Permit for its Municipal Separate Storm Sewer System (MS4) on May 10, 2003. With this report, Hadley will have complete all mandated filings for that five-year General Permit.

Throughout the five-year permit period Hadley has made great strides toward a more environmentally sustainable stormwater management policy. Specifically, the Town has:

- Distributed stormwater management fact sheets to residents in their in water bills.
- Presented informational programs regarding stormwater on their cable access channel.
- Established a Stormwater Management Steering Committee to oversee permit implementation.
- Partnered with the Massachusetts Highway Department to collect all existing utility records and created a Stormwater System Map within the Urban Area.
- Field checked and amended the Stormwater System Map.
- Completed an Illicit Connection Detection Program through the use of dry weather screening and water sampling.
- Partnered with the Pioneer Valley Regional Planning Commission to draft Stormwater Management By-laws.
- Held public meetings and enacted, though Town Meeting, Stormwater Management and Illicit Discharge By-laws.
- Conducted training for public works employees covering good housekeeping practices including spill prevention and control.
- Maintains a program of reducing winter salt on roadways thought the use of alternative deicing methods.

The work under this program has essentially completed all of the items outlined in the initial Notice of Intent for the General Permit.

Stantec is of the opinion that the Town of Hadley has successfully executed its responsibilities under the General Permit.

2.0 Assessment of the Appropriateness of Selected BMPs

The selected Best Management Practices (BMPs) seem to have advanced the goal of the reduction of pollution due to stormwater runoff. The Planning Board now regularly reviews all applicable plans for their Stormwater Management Design, and uses outside consultants to review complicated systems.

Through its Highway Department personnel, the Town has continued to verify and make revisions to the Stormwater System Map within the Urban Area.

The television program "After the Storm", produced by the EPA and provided by the Weather Channel, continues to be shown periodically on Hadley Cable Access Television.

Municipal good housekeeping continued to be an aim of the Department of Public Works (DPW).

The use of calcium chloride as a deicer to replace winter road salt was increased each winter since the Permit has been in effect.

The NPDES Steering Committee, having enacted local by-laws and executed the terms of the General Permit, no longer holds regular meetings. Its members were drawn from Town employees, boards and committees, with Stantec offering technical advice when needed. Most members, therefore, are still actively involved in the Town.

With the force of the by-law, the Town remains vigilant in preventing and eliminating illicit discharges.

3.0 Progress Towards Measurable Goals

3.1 GOALS

The following measurable goals were proposed for implementation during the term of this program, and were completed as shown:

1. Partnership with Lake Warner-Mill River Steering Committee.
This committee has been dissolved.
2. Distribution of a Stormwater Fact Sheet with the spring water bills.
Completed.
3. Presentation of an informational video on Hadley Cable Access Television.
Completed.
4. Establishment of a NPDES Steering Committee.
Completed.
5. Partnership with the Massachusetts Highway Department to map the storm drainage within the Route 9 corridor.
Completed.
6. Begin mapping the Town-owned Storm Drainage System within the Urban Area.
Completed.
7. Dry weather screening and video inspection.
Completed.
8. Establish illicit discharge hotline.
Not established.
9. Drafting a by-law for the prevention of illicit discharges.
Completed.

10. Drafting a by-law for disturbances of over one acre of land.

Completed.

11. Drafting a by-law for the control of post-construction stormwater runoff.

Completed.

12. Implement Spill Prevention Control Plan at the DPW yard.

Completed.

13. Conduct training for maintenance and landscaping crews.

Informally completed.

14. Incorporate the use of a road salt alternate for winter deicing of roadways.

Completed.

4.0 Summary of Results

In summary, during the term of the permit, the Town of Hadley has:

- Distributed a fact sheet on urban runoff to all households and businesses.
- Televised an educational stormwater video on its Cable Access Channel.
- Formed a Steering Committee to shape and implement the Town's Stormwater Policy.
- Prepared a map for the Storm Drainage Inventory within the Town's urban area, in partnership with the Massachusetts Highway Department (MHD).
- Implemented a Dry Weather Illicit Discharge Screening Program.
- Adopted Stormwater By-Laws and an Illicit Discharge Ordinance.
- Continued to implement a Spill Prevention Program at the DPW yard.
- Continued to reduce the amount of road salt used for deicing.
