## FEDERAL ROLE IN OPEN DUMPING ENFORCEMENT

---

- EPA role dictated by the Resource Conservation and Recovery Act (RCRA) – main authority for regulating solid waste rests with states, tribes, local governments, and solid waste facility operators.
- EPA enforcement authority for solid waste is limited to situations posing “imminent and substantial endangerment” to human health or the environment.
- EPA cannot grant federal inspection/enforcement credentials to non-federal entities for solid waste



## FEDERAL ROLE IN OPEN DUMPING ENFORCEMENT

---

- RCRA Section 7003: Imminent and Substantial Endangerment is a powerful federal tool EPA uses to address serious threats from solid or hazardous waste when people or the environment are at risk. When used in Indian Country, EPA coordinates closely with tribal governments.
- EPA typically uses 7003 when there is a credible, serious threat to health or the environment tied to the handling, storage, treatment, transportation, or disposal of waste, and when a person or entity can be identified that has contributed to the problem (past or present owner/operator, waste generator/arranger, or transporter).



# FEDERAL ROLE IN OPEN DUMPING ENFORCEMENT

---

- Situations on tribal lands that have triggered or can trigger 7003:
  - Landfills or waste pits with failing controls.
  - Large tire piles that catch fire, producing thick smoke and contaminated runoff.
  - Improper disposal of pesticides and agricultural chemicals.
- RCRA 7003 Orders can require:
  - Stop the dangerous activity (e.g., halt dumping, burning, or leaking).
  - Secure the site (fencing, signage, 24/7 security).
  - Provide immediate protections (e.g., alternative drinking water, vapor ventilation, dust suppression).

# PREVENTION BEFORE ENFORCEMENT

Operate a Solid Waste system

Conduct education & outreach on proper disposal & illegal dumping

Post signs regarding:

- Information on transfer station hours

- Ordinances

- Fines

Barricade dumping sites

Trail & Security Cameras





## CODES AND ORDINANCES: BIG PICTURE

---

From ITEP Codes and Ordinances training:

- Does your tribe have a Solid Waste Code?
- Are you starting from scratch or updating?
- What is the specific issue which needs to be addressed?
- Precise terms enable compliance, enforcement.
- Be proactive, not reactive.
- How will you involve the community?
- How will the law be enforced?



## CODES AND ORDINANCES:

- Work with your tribal attorney
- Public review and comment options for tribal members at all stages of the process
- Post ordinance on web
- Work with your council – ensure they support implementation

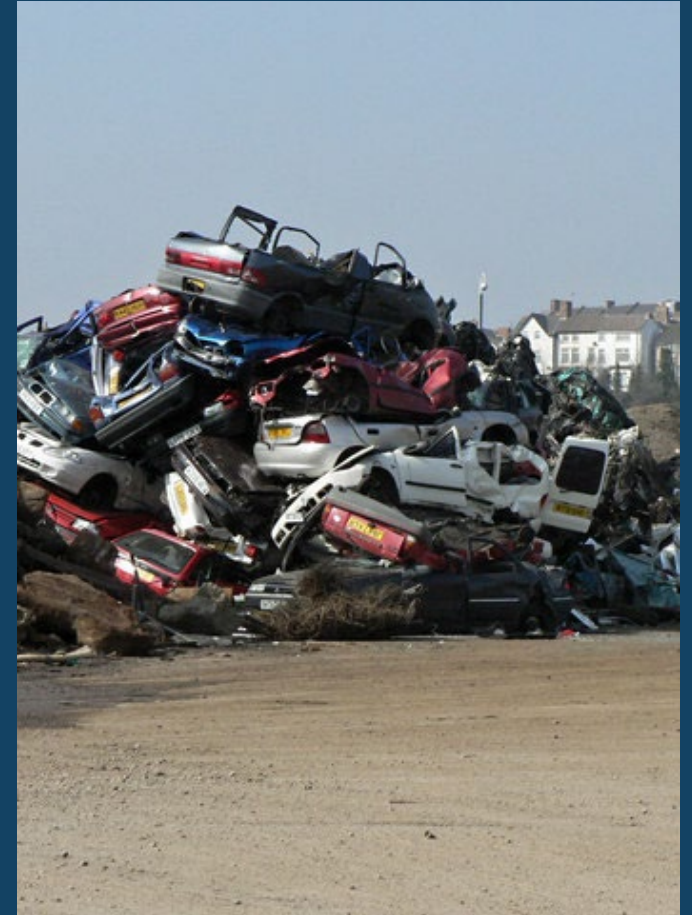

# ENFORCEMENT APPROACHES



- Create a code that has explicit penalties for violations
  - Example: Yurok Tribal Code re Illegal Dumping Section 21.40
- Work with state, county, or local LEOs on code enforcement
  - Joint powers agreements
  - MOUs
  - Cross-certification/deputization

# IMPLEMENTATION: GAP FUNDING

## GAP funds can be used for

- ISWMP development
- Development of code and ordinances
- Outreach and education
- Compliance monitoring, assistance and enforcement programs
- Limited clean up





# IMPLEMENTATION: OTHER FUNDING

## SWIFR (Solid Waste Infrastructure for Recycling)

- Recycling infrastructure and planning

## Brownfields 128(a)

- Can fund program costs associated with prevention, assessment, and remediation of brownfields.
- Activities include planning, training, program development, outreach, enforcement, site assessment and cleanup (only for defined Brownfields)
