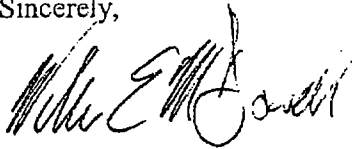

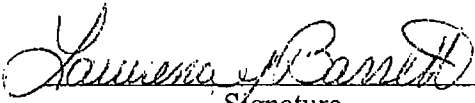

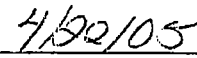

Part II. Self- Assessment

The Town of Stoughton has completed the required self-assessment and has determined that our municipality is in compliance with all permit conditions with the following exceptions:

Notice of Intent Section 1 – Public Education and Outreach – BMP's # 2, 4

The Public Education and Outreach effort includes two tasks that are to be created with students at the High School both for purposes of including members of the community, and utilizing resources available to the High School that are not available to the Town, such as video recording and post production equipment. The current media teacher at the High School has retired and the Technical Committee is scheduling meetings with the incoming teacher to create a schedule that will match with existing curriculum goals to produce both the video and provide imagery for the Stormwater fliers to be distributed throughout the Town with water bills. It is the Committee's intent to have a contest for student artwork to be included with the fliers.

Notice of Intent Section 3 - Illicit Discharge Detection and Elimination - BMP's # 9, 10:

The Illicit Discharge Detection and Elimination effort begins with mapping the existing drainage system. At this time, changes in staffing levels at the Town have eliminated three positions directly responsible for the mapping effort. The Engineering Department is currently pursuing funding for a contractor to perform the survey work required to locate individual drain outfalls in the field.

Part IV. Summary of Information Collected and Analyzed

The Engineering Department will not be replacing two personnel responsible for field data collection and in house mapping and plan production. In addition, implementation of the Town's GIS has been delayed by staffing problems. This has altered the resources available to perform tasks noted in the Notice of Intent. The Engineering Department and the Technical Review Committee are investigating funding mechanisms to contract the mapping portion of the Illicit Discharge Detection and Elimination out. The decision to reduce staff was made after the Department's ability to seek funding through the Town Meeting Warrant. The Department is actively seeking grant money and preparing material for a warrant article on the next available Special Town Meeting or the 2006 Annual Town Meeting. This will delay the creation of the Town Wide Map, however, mapping of portions of the Town's drainage system using existing utility as-built plans and subdivision design plans is ongoing. The ultimate goal will not be delivered according to the schedule noted in the NOI but every effort is being made to meet the measurable goal prior to the expiration of the General Permit in May 2008.
