Dear Ms. Garcia,

I am writing as the property owner of (b) (6) Privacy, (b) (7)(C) Enf. Privacy and the principal behind the (b) (6) Privacy, (b) (7)(C) Enf. Privacy forensic audit to provide a critical update regarding the administrative complaint involving Georgetown County, SC (**EPA No. 15-26-R4**).

Please be advised that as of today, February 10, 2026, I have formally filed a report with the **Federal Bureau of Investigation (FBI) Public Corruption Division**. This escalation is a direct result of coordinated administrative obstruction by state and local officials.

As of 8:11 AM this morning, my professional domain was "Hard Blocked" (**Error 550 5.4.1**) by South Carolina state servers to suppress the delivery of forensic evidence regarding 32 years of HUD CDBG infrastructure fraud at this site. Because the **South Carolina Department of Environmental Services (SCDES)**—the agency referenced in your Feb 6th correspondence—is a party to this digital blockade, I am requesting that the EPA External Civil Rights Division coordinate its findings directly with the FBI.

**Confidentiality & Anti-Retaliation Request:** Pursuant to the Privacy Act and **40 C.F.R. § 7.100**, I am requesting the maximum degree of confidentiality permitted.

Given that the State of South Carolina has already implemented a digital blockade to obstruct my reporting, I have a well-founded fear of further administrative retaliation. I request that my personal contact information and identity be shielded from the SCDES and Georgetown County officials to the greatest extent possible during this investigation.

***The state's attempt to silence a Title VI complainant through digital interference is a direct violation of federal whistleblower protections. I am now communicating via this personal email to ensure these facts reach you despite the state's efforts to obstruct justice.***
