Hello,

I am writing to formally file a Title VI complaint with the U.S. Environmental Protection Agency's External Civil Rights Compliance Office (ECRCO). The respondent is the City of Los Angeles.

This complaint concerns discriminatory environmental and procedural practices affecting the Skid Row community, including disparate environmental burdens, the exclusion of Skid Row from environmental review processes, the absence of meaningful access, and the City's failure to provide nondiscriminatory treatment in decisions involving environmental impacts. The discriminatory environmental and procedural harms described in the complaint are ongoing, and the City continues to take actions within the 180-day window that perpetuate these violations.

I have previously copied EPA on related filings to the City of Los Angeles Civil Rights Department for transparency, but this email constitutes my formal federal submission for intake and review.
