The Town has undergone a transition and a new Conservation/Stormwater Agent recently assumed the role of MS4 Program Manager for the Town. While reviewing the permit requirements versus what has been completed to date, it has become apparent that the Town fell behind in meeting some of the 2016 Permit requirements during the transition phase. This includes completing dry weather screening of all outfalls (except Problem and Excluded outfalls) and the required updated outfall/interconnection priority ranking. In the past the Town had been working with Buzzards Bay Stormwater Collaborative (BBSC) who had been assisting the Town with outfall mapping and screening, stormdrain connectivity mapping, etc. However, during this recent permit year, the agreement with BBSC had lapsed, and therefore, outfall screening did not continue through the permit year. The new MS4 Program Manager has been reviewing all information available regarding compliance with the 2016 Permit and has been in contact with BBSC to discuss actions that are needed to bring the Town into compliance with the permit requirements. Over this current permit year, the Town will focus on ensuring that it is up-to-date with all of the permit requirements.

The Town did review and update its Stormwater Bylaw during Year 3. The revised Bylaw was approved at the 2021 spring Town Meeting.

As stated above, the Town has undergone a transition and a new Conservation/Stormwater Agent recently assumed the role of MS4 Program Manager for the Town. This transition, along with COVID-19 meeting restrictions, impacted the Town's ability to complete a number of the above listed tasks. The new Program Manager is reviewing all of the tasks that have been completed to date and is in the process of developing a compliance schedule to ensure that the Town is current with all of the permit requirements by the end of permit year 4.

Although the section regarding catchbasin cleaning above indicates that no catchbasin cleaning was performed, the Acushnet DPW DID perform catchbasin cleaning during Year 3. The Town's DPW Director is currently on medical leave, and therefore, the actual number of catchbasin that were cleaned, and the amount of material removed could not be confirmed. Therefore the Town did not fill in that section of the report.

COVID-19 did impact the Town's ability to meet the public participation and employee training requirements of Year 3. The transition of the a new and recently appointed Conservation Agent to the MS4 Program Manager role was also restricted by COVID-19 meeting requirements and limited access to the Town Hall offices.

The Program Manager is working with a stormwater consultant to ensure that the requirements of all of the MCMs are fulfilled and is also is re-visiting the Town's relationship with BBSC to request their assistance in complying with the outfall and catchment screening and mapping components of the

permit.
