1. Although not publicly advertised, the SWMP is available for review on the Town's website. Comments are welcome. Our consultant is in the process of updating our SWMP and it is expected that a new version will be available in Year 8.
2. Our consultant is continuing to review the Town's system mapping, and these updates will continue through Year 10.
3. An employee training program was initiated in Year 6 and during Year 7, the program was initially implemented. Focus will be on full implementation during Year 8 for all employees that are involved with MS4 compliance.
4. SWPPPs had been developed for Town-owned facilities and inspections continued.
5. SOPs and O&M programs were developed in a previous year. During Year 8, our consultant will review and improved if necessary.
6. Inspections of Town-owned treatment structures will begin in Year 8.

1. Although there are no water bodies in Acushnet that are Category 4a, water bodies with a completed TMDL, there are Category 5 water bodies present for pathogens. Therefore, the Town is following the Appendix H and F requirements.

2. Acushnet, through our consultant, began its public education program during the 4th quarter of 2023 with the intention of expanding the program during Year 7. During Year 6, our program started with the creation and dissemination of educational brochures that address (1) Pet Waste (residents); (2) Gas , Oil & Grease spills and leaks (industrial); (3) Erosion (Developers); and (4) Solid Waste Management (Businesses). The prepared brochures were created from templates produced by Think Blue Massachusetts and were distributed throughout Town buildings. The Town has continued with the dissemination of this information and will be looking to include social media postings in Year 8.

Both dry and wet weather screening and sampling of regulated outfalls was completed by the end of Year 7. Wet weather sampling information was being summarized at the end of Year 7 and at the time of this annual report, the summary had yet to be completed and uploaded to the above referenced shared drive. After a slow start, Acushnet is aggressively trying to become fully compliant based on available funding.


